THIRTEENTH COUNTY BOARD MEETING

TUESDAY, FEBRUARY 22, 2011 Rescheduled due to inclement weather THURSDAY, FEBRUARY 24, 2011

The Pendleton County Board of Education convened in Regular Session on Thursday, February 24, 2011, at the Pendleton County Middle/High School. The following members were present: J. D. Wilkins- President, Richard Gillespie- Vice-President, Teresa Heavner, Sonny O'Neil, Betty Kimble. Central Office Staff present: Douglas Lambert, Superintendent, J. P. Mowery, Donald Bucher, Ann Bennett, Charles Hedrick and Nancy R. Blankenship. Also Present – Shelba Vincell, Timothy Woodward, Lance Moran, Rebecca McConnell, and Robert Tuckerman.

Prior to the Board Meeting at 5:00 P.M. the Board of Education conducted a student expulsion hearing in closed session. Upon a motion by Mr. Gillespie seconded by Mr. O'Neil the Board convened in Executive Session at 5:20 P.M. The Board returned to regular session at 5:25 P.M. Upon Mr. Lambert's recommendation and a motion by Mr. O'Neil seconded by Ms. Kimble the Board voted unanimously to expel Student #2010-2011-4 for a period of one year (365 days) beginning February 24, 2011. Upon a motion by Mr. O'Neil seconded by Mr. Gillespie the Special Session was adjourned at 5:30 P.M.

The Pendleton County Board of Education met at 5:30 for a dinner hosted by Pendleton County Middle/High School FCCLA teacher and students. The dinner was followed by the Board of Education meeting with the Pendleton County Middle/High School LSIC/Faculty Senate/School Curriculum Team. There was a recognition session recognizing students who scored "Distinguished" on the Spring WESTEST2, Pendleton County Middle/High School for achieving Full Accreditation Status according to West Virginia Office of Educational Performance Standards for the 2010-2011 School Term, and Mr. Woodward recognized students who responded to the parent tragedy that had happened at the school. This part of the meeting was concluded at 7:45 P.M.

Call to Order by the President: President Wilkins called the meeting to order at 7:50 P.M.

Pledge of Allegiance and Invocation: Mr. Lambert led the Pledge of Allegiance and Mr. Wilkins led the group in prayer.

Public Comment: There was no public comment.

Presentations:

Pendleton County Library: Bob Tuckerman and Rebecca McConnell were present representing the Pendleton County Library. The Library is requesting that the Board of Education budget \$6,000 to support the operation of the Pendleton County Library in FY12. Mr. Tuckerman talked about funding sources and funding needed. Becky McConnell talked about things that the Library does for the schools.

The minutes of the February 8, 2011, Board Meeting: Upon Mr. Lambert's recommendation and a motion by Mr. O'Neil, seconded by Ms. Kimble the Board voted unanimously to approve the minutes of the above Board Meeting.

Retirements/Resignations: Monica Flippin – Substitute Teacher. Upon Mr. Lambert's recommendation and a motion by Ms. Kimble seconded by Mr. O'Neil the Board voted unanimously to approve the above retirements/resignations.

Rescission of Retirement: David Warner - Teacher PCM/HS. Upon Mr. Lambert's recommendation and a motion by Mr. Gillespie seconded by Ms. Kimble the Board voted unanimously to approve the rescission of the above retirement with Ms. Heavner abstaining

from the vote.

Finance:

Mr. Mowery presented a funding analysis for professional personnel and service personnel. Mr. Mowery presented a preliminary budget for FY 2011-2012.
