#### **ARTICLE I: NAME**

The name of this chapter shall be the Lawrenceville High School Chapter of the National Honor Society .

#### **ARTICLE II: PURPOSE**

The purpose of this chapter shall be to create an enthusiasm for scholarship, to stimulate a desire to render service, to promote worthy leadership, and to encourage the development of character in students of Lawrenceville High School.

# **ARTICLE III: POWERS**

- **Section 1.** This chapter operates under the direction of and in full compliance with the NHS National Constitution. See www.nhs.us/constitutions.
- **Section 2.** The chapter adviser is given the authority to supervise the administration of chapter activities, as delegated by the school principal.
- Section 3. Final authority on all activities and decisions of the chapter resides with the school principal. (See Article V, Section 1 of the National Constitution.)
- Section 4. Nondiscrimination. Our chapter of NHS maintains policies and practices that are designed to prevent discrimination against any qualified candidate or member on the basis of race, color, religion, ancestry, national origin, gender, and disability. This policy of nondiscrimination applies to all practices, including the chapter administration and the selection, discipline, and dismissal of members.

### **ARTICLE IV: MEMBERSHIP**

- **Section 1.** Membership in this chapter is an honor bestowed upon deserving students by the faculty and shall be based on the criteria of scholarship, service, leadership, and character.
- Section 2. Membership in this chapter shall be known as active, honorary, and alumni. Active members become alumni members at graduation. Honorary members are selected at the discretion of the faculty council. Alumni and honorary members have no voice or vote in chapter affairs.

## Section 3. Eligibility:

- a. Candidates eligible for selection to this chapter must be members of the junior, or senior class.
- To be eligible for selection to membership in this chapter, the candidate must have been enrolled for a period equivalent to one semester at Lawrenceville High School.
- c. Candidates eligible for election to the chapter shall have a minimum cumulative grade point average of 3.5 on a 4.0 scale.

d. Upon meeting the grade level, enrollment, and GPA standards, candidates shall then be considered based on their service, leadership, and character.

#### ARTICLE V: SELECTION OF MEMBERS

- Section 1. The selection of members to this chapter shall be by the review of student applications by the faculty council, which consists of five faculty members appointed by the principal. The chapter adviser shall be the sixth, nonvoting, ex-officio member of the faculty council.
- **Section 2.** The selection of active members shall be held once a year during the first semester of the school year.
- Section 3. Prior to the final selection, the following shall occur:
  - a. Students' academic records shall be reviewed by the adviser to determine scholastic eligibility.
  - All students who are eligible scholastically (i.e., candidates) shall be notified and asked to complete and submit the candidate application for further consideration.
  - c. The faculty council shall review the candidate applications to determine those who fully meet the selection criteria for membership based on the faculty council rubric.
  - d. The adviser will calculate the results based on the formula listed in the selection process description.
  - e. Results will be reported to the faculty council for a final vote.
  - f. Candidates will be informed in writing of their selection or rejection.
- **Section 4.** Candidates become members when inducted at a special ceremony.
- **Section 5.** An active member of the National Honor Society who transfers from this school will be given an official letter indicating the status of his/her membership.
- Section 6. An active member of the National Honor Society who transfers to this school will be automatically accepted for membership in this chapter upon receipt of a letter stating that they were a member in good standing at their former school. The faculty council shall grant to the transferring member one semester to attain the membership requirements and, thereafter, this member must maintain those requirements for this chapter in order to retain his/her membership.

# ARTICLE VI: APPEALS IN THE CASE OF NON-SELECTION

- **Section 1.** If a candidate appeals their non-selection, the Following process will be followed:
  - a. A review by the chapter adviser of the information provided by the Faculty Council session.
  - Submission of the relevant information to the principal who consults with the faculty council and/or adviser(s) regarding their decisionmaking process.
- Section 2. Outcomes of an appeal can include:
  - a. Rejection of the appeal; sustaining the original judgment.
  - b. Request from the principal for the faculty council to reconsider the case.
  - c. A change in decision of the faculty council, resulting in the selection of the student in question.
- **Section 3.** Candidates that are still not satisfied with the result of the appeal decision will move to the next step in the school hierarchy: the superintendent.
- **Section 4.** Appeals must be requested within one week of the selection decision.

### **ARTICLE VII: OBLIGATIONS OF MEMBERS**

- Section 1. Members shall not pay dues.
- Section 2. Each member of this chapter who is in good standing with regard to the membership standards and member obligations shall be granted the privilege to wear the emblem adopted by the National Honor Society.
- **Section 3.** Any member who withdraws, resigns, or is dismissed from the chapter shall surrender the privilege of wearing the emblem to the chapter.
- **Section 4.** Chapter members who are seniors in good standing shall be granted the privilege of wearing the honor cords at graduation.

### **ARTICLE VIII: OFFICERS**

- **Section 1.** The officers of the chapter shall be president, vice president, and secretary.
- Section 2. Student officers shall be elected at the first meeting of each school year. All returning members in good standing with the chapter are eligible to run for a position as an officer. Any active member can nominate an eligible member as a candidate for office.

- Section 3. Voting shall be by show of hands with candidates removed from the room. A majority vote shall be necessary to elect any officer of this chapter. If the first vote does not yield a majority, a second vote shall be taken of the two candidates receiving the highest number of votes.
- **Section 4.** It shall be the duty of the president to preside at the meetings of the chapter, and serve as the official representative of the chapter at school and community functions.
- **Section 5.** The vice president shall preside in the absence of the president.
- **Section 6.** The secretary shall keep the minutes and attendance records for meetings and be responsible for all official correspondence.
- Section 8. Officers and the faculty adviser(s) shall collectively be known as the chapter's executive committee.

  The executive committee shall establish annual goals for the chapter and have general charge of the meetings and the business of the chapter.

  Any action by the executive committee is subject to the review of the chapter members.

### **ARTICLE IX: MEETINGS**

- **Section 1.** Meetings of this chapter will be called by the adviser. Special meetings can be called by the president with the approval of the adviser.
- **Section 2.** This chapter shall conduct its meetings according to *Robert's Rules of Order*.
- **Section 3.** Members are expected to attend all chapter meetings.

# **ARTICLE X: ACTIVITIES**

- **Section 1.** The chapter shall determine one or more service projects for each year.
- **Section 2.** All members shall regularly participate in these projects.
- Section 3. These projects shall have the following characteristics: fulfill a need within the school or community, have the support of the administration and the faculty, be appropriate and educationally defensible, and be well planned, organized, and executed.
- **Section 4.** Members shall help with one parent/teacher conference per year.
- **Section 5.** Members are expected to participate in any fundraisers to help pay for chapter dues.
- **Section 6.** The chapter shall publicize and promote its projects in a positive manner

# ARTICLE XI: DISCIPLINE and DISMISSAL of MEMBERS

- Section 1. Any member who falls below the standards of scholarship, service, leadership, or character may be considered for discipline or dismissal from The Lawrenceville High School chapter of the National Honor Society. A member of the National Honor Society is expected to maintain his/her academic standing and take an active role in service and leadership in his/her school and community.
- Section 2. If a member's cumulative grade point average falls below the standard in effect when he/she was selected (3.5) or a member ends a quarter or semester with a D or F, he /she will be given a written warning and a reasonable time period for improvement. If the cumulative grade point average remains below the standard or the D or F remains at the end of the warning period, the student will be subject to further disciplinary action by the faculty council that can include consideration of dismissal from the chapter.
- Section 3. Violations of the law or school regulations can result in immediate consideration of the dismissal of a member (see Section 5 below). These violations include, but are not limited to DWI; stealing; destruction of property; cheating; truancy; or possession, selling, or being under the influence of drugs or alcohol at school or school-related activities or in the community.
- Section 4. Offenders of the school conduct code (such as use of profanity, failure to comply, unexcused absences, excessive tardiness, etc.) will receive written warning notification. A conference may be requested by either party (faculty council or student/parent). If the member is involved in another violation of the school conduct code, the member may be considered for dismissal.
- **Section 5.** Chapter officers, as representatives of the chapter, can be removed from their positions as a consequence of disciplinary action taken by the faculty council.
- Section 6. In all cases of pending dismissal:
  - a. The member will receive written notification from the adviser/faculty council indicating the reason for consideration of dismissal.

- b. The member will be given the opportunity to respond to the charge(s) against him/her at a hearing before the faculty council prior to any vote on dismissal (in accordance with due process identified in Article X of the National Constitution). The member has the opportunity to present his/her defense either in person or via a written statement presented in lieu of the face-to-face hearing. Following the hearing, the faculty council will then vote on whether to dismiss. A majority vote of the faculty council is needed to dismiss any member.
- c. The results of the faculty council vote will be presented to the principal for review, and then stated in a letter sent to the student and parents. Dismissed members must surrender any membership emblems to the adviser.
- d. The faculty council's decision may be appealed to the building principal and afterwards according to provisions of the school district discipline policies.
- **e.** A member who is dismissed or resigns may never again be considered for membership in the National Honor Society.
- **Section 7.** In lieu of dismissal, the faculty council may impose disciplinary sanctions upon a member as deemed appropriate.

# ARTICLE XII: RATIFICATION, APPROVAL, and REVIEW.

- Section 1: These bylaws will be approved upon receiving a two-thirds affirmative vote of all active members of the chapter, a majority affirmative vote of the faculty council, and approval by the administration.
- **Section 2:** These bylaws shall be reviewed and if necessary, revised within five years from the date of approval noted on this document.

#### **ARTICLE XIII: AMENDMENTS**

These bylaws may be amended by a two-thirds vote of the chapter, provided notice of the proposed amendment has been given to members at least one month prior to the vote. The exceptions are Articles V and XI, which are developed by the faculty council with the approval of the principal (selection and discipline).
