MINUTES OF SCHOOL COMMITTEE VIRTUAL MEETING - January 14, 2021

Also, in attendance was Theresa Moore of T-Time Production.

Gina Bae called the working session to order at 6:37 p.m and explained the format of tonight's workshop and then turned the meeting over to Theresa Moore.

Ms. Moore explained as a follow up from the last meeting in October the group will be split up into six smaller groups (with no more than one school committee member per group) to do a deeper dive into the categories that were identified in October and look at the obstacles and issues specific to those categories, such as resource allocation, curriculum, hiring and retention, etc.

The smaller groups met for approximately an hour and then came back into the large group to have each of the smaller groups share their topics and identify the obstacles/issues specific to their categories. The topics of the conversations will be put together into a more comprehensive document so that the school committee and other district leaders can start working on solutions to the come of the challenges and obstacles identified in each of the categories.

Ms. Bae thanked Ms. Moore and all of the administrators for attending this important workshop and she looks forward to the continued work.

Ms. Bae excused all of the administrators except for Mr. Messore, Dr. Dillon, and Mr. Fiore at that time.
