Jeanette Starkey (substitute teacher) – The school is doing a fabulous job at keeping the kids in school. She believes there are no issues with the children wearing masks and following the distant rules. She personally thinks the school is the safest place for our students to be.

There was discussion among the Board and those in attendance about children in quarantine and how they are learning. Mr. Doak asked Mrs. Beardsley and Mrs. Baumgard what their personal thoughts were. Mrs. Beardsley stated that she was a "data" person and the survey WCLEA sent to staff supports OEA's recommendation of a restart date of January 11, 2021. Mrs. Beardsley states that she is hearing frustration about not keeping up with students who are out, not understanding Google meets and wants the Board to entertain the option of going Virtual.

Mrs. Baumgard stated the Elementary staff is overwhelmed with being with students all the time, not having a break. Staff has limitations on "hand on" items because of the amount of time to sanitize. Staff would like to see the Elementary work at a different pace. Mrs. Baumgard suggested that a team be put together, directed at COVID, to discuss the next direction when school returns in January.

There was discussion on athletes being quarantined and what effects it has in the classrooms, especially in the lower grades. Mr. Baldwin stated that PeeWee sports are on hold until further notice. The Junior High and High School athletes will continue to play as long as there are enough and opponents are able to play.
