Board member, Kevin Delancey, addressed the board regarding the delay of winter sports. He asked the board to make a public declaration show lack of support of current MDHHS Epidemic Order regarding the delay of winter contact sports. Mr. Lukshaitis presented a drafted letter to the board, written to Governor Gretchen Whitmer requesting the start of winter contact sports to convene as early as February 1, 2021. With Board approval, Mr. Lukshaitis offered to mail letter to Governor Whitmer, post a copy to the school's website and send a copy to the Cadillac News as a press release. He received unanimous board support of this offer.

Mr. Shook asked about plans to improve the district's air quality/HVAC systems. Mr. Lukshaitis advised that options are being explored and estimates/quotes sought regarding this matter. Mr. Shook also advised that if the district is ever considering moving to a "balanced calendar" then air conditioning in classrooms should also be explored.
