Grounds Laborer

DISTINGUISHING FEATURES OF THE CLASS:

The work involves performing routine manual work requiring physical endurance and willingness to perform a variety of routine and repetitive tasks. Directs work assignments and reviews work completed. Supervision may be exercised by this class over part-time, seasonal and lower ranking maintenance and cleaning personnel. Does related work as required.

TYPICAL WORK ACTIVITIES:

1. Cleans and services buildings by sweeping and mopping offices, halls, stairways, etc;
2. Vacuums carpets, waxes and buffs floors with mechanical equipment;
3. Scrubs and cleans all areas of lavatories such as sinks, toilets, urinals, etc.;
4. Cleans lighting fixtures, replaces light bulbs, and washes windows, moves furniture and equipment and washes walls;
5. Assists with outside work such as sweeping walks, shoveling snow, cutting lawns, trimming hedges, may use lawn mower and riding snow plowing equipment, etc.;
6. Loads, unloads trucks and stocks supplies;
7. Picks up and disposes trash or soiled linen and operates clothes washing machine;
8. Gathers and disposes refuse;
9. Complies with various Occupational Safety and Health Administration (OSHA) laws and regulations, including reading and understanding Material Safety Data Sheets relating to hazardous materials and other substances;
10. Replenishes lavatory supplies;
11. Can act as a messenger.
12. May be required to operate a District vehicle; therefore, possession of a valid New York State motor vehicle license will be required.
13. May be assigned other tasks by Supervisor.

FULL PERFORMANCE KNOWLEDGE, SKILLS, ABILITIES AND PERSONAL CHARACTERISTICS:

Working knowledge of the maintenance and repair of buildings, fixtures, and equipment; ability to make a variety of simple repairs and adjustments to buildings and equipment; ability to lift medium weights; willingness to perform routine manual work; willingness to work under all weather conditions; physical condition commensurate to perform the essential functions of the job with or without reasonable accommodations.

MINIMUM QUALIFICATIONS:

Housekeeping Laborer

DISTINGUISHING FEATURES OF THE CLASS:

The work involves performing routine manual tasks in the care and cleaning of buildings. The work requires the performance of simple cleaning tasks which require frequent bending, stretching, stooping and walking. Work is performed under the direct supervision of a higher ranking custodial or administrative employee. Does related work as required.

TYPICAL WORK ACTIVITIES:

1. Cleans and services buildings by using mops, brushes, detergents, and other cleaning implements to wash floors, corridors, stairs and stairwells, walls, partitions and windows;
2. Cleans lighting fixtures, replaces light bulbs, and washes windows, moves furniture and equipment and washes walls in connection with cleaning and care function;
3. Vacuums carpets, dusts woodwork, furniture and fixtures;
4. Waxes and buffs floors with mechanical equipment;
5. Scrubs and cleans all areas of lavatories such as sinks, toilets, urinals, etc. Replenishes lavatory supplies;
6. Polishes wood and metal fixtures and equipment;
7. Gathers and disposes refuse;
8. Complies with various Occupational Safety and Health Administration (OSHA) laws and regulations, including reading and understanding Material Safety Data Sheets relating to hazardous materials and other substances;
9. May be assigned other tasks by Supervisor.

FULL PERFORMANCE KNOWLEDGE, SKILLS, ABILITIES AND PERSONAL CHARACTERISTICS:

Working knowledge of the properties of various cleaning substances; ability to understand and follow verbal and simple written instructions; ability to stand, stoop, bend and stretch for long periods of time; ability to use various cleaning equipment and products; thoroughness; dependability, physical condition commensurate to perform the essential functions of the job with or without reasonable accommodations.

MINIMUM QUALIFICATIONS:

There are no education or experience requirements. Applicants must be able to perform light laboring tasks.
