

DUAL PARTICIPATION AGREEMENT
BETWEEN

NAVARRO HIGH SCHOOL
AND
TEXAS LUTHERAN UNIVERSITY

Texas Lutheran University and Navarro Independent School District on behalf of Navarro High School enter into the following agreement:

1. PURPOSE: The purpose of this agreement is to facilitate the cooperation between TLU and Navarro High School in the provision of instruction of dual credit courses for Navarro High School students.
2. PROVISION OF COURSES: TLU is currently accredited by the Southern Association of Colleges and Schools as required and meets all the SACS requirements to offer dual credit courses to School. TLU shall give college credit for all courses listed in the TLU catalog.
3. INSTRUCTION OF COURSES: TLU will designate staff personnel to monitor the instruction of the dual credit course(s) to assure the instruction is in accordance with the requirements and standards established by the State of Texas, the Southern Association of Colleges, School, and TLU. Instruction will be offered in the TLU equivalent of Biological Systems I, BIOL-143, and Biological Systems II, BIOL-144.
4. FACILITIES: Course(s) will be conducted at Navarro High School.
5. TUITION, FEES, and BOOKS: NISD agrees to pay the tuition costs for its students and provide necessary laboratory supplies. For classes taught at Navarro High School, NISD will reimburse TLU \$500 per four credit hour course. Students participating in the program are responsible for textbooks and any other educational supplies required for courses.
6. ENROLLMENT: Students desiring academic credit from TLU will enroll for each course. Upon mutual agreement, TLU will conduct enrollment one time per semester. Students failing to enroll or failing to complete enrollment procedures at that time will complete the necessary procedures at TLU during usual business hours.
7. INSTRUCTORS: The instructor(s) will meet the requirements and standards of TLU, the Southern Association of Colleges as well as those set by Navarro High School.
8. STUDENT REQUIREMENTS: students must meet the eligibility requirements for participation in AP classes at Navarro High School in the appropriate subject area; provide a copy of the student's high school transcript; meet the course prerequisites as published in the TLU catalog.

9. TERM: This agreement shall be in effect for the 2020-2021 academic year.
10. BOTH PARTIES AGREE:
- a. To comply with all applicable provisions of the Family Education and Privacy Rights Act 20 USC – 1232g.
 - b. In all cases, to comply with all federal, state, and local laws applicable to this agreement.
 - c. To have in place and abide by a policy prohibiting sexual harassment and misconduct.
