During the non-test session, examinees may also opt-in to the Educational Opportunity Service (EOS), which provides information from colleges, universities, financial aid/scholarship agencies, and organizations that offer educational programs.

The Family Educational Rights and Privacy Act (FERPA) (20 U.S.C. § 1232g; 34 CFR Part 99) is a Federal law that protects the privacy of student education records. The law applies to all schools that receive funds under an applicable program of the U.S. Department of Education. FERPA gives parents certain rights with respect to their children's education records. These rights transfer to the student when he or she reaches the age of 18 or attends a school beyond the high school level. Students to whom the rights have transferred are "eligible students." Pursuant to Ark. Code Ann. § 6-18-109 ("The Student Online Personal Information Protection Act of 2015"), online services are restricted in the use of public school students' personal identifiable information.
