
I am writing to inform you that ten (10) students who attends **Valley High School** has recently had close contact with an individual who has COVID-19. The students are self-quarantining at home, have displayed no symptoms of the virus and have not tested positive for the virus. Due to privacy laws, we cannot disclose further information about the students. Whenever a person has recently had close contact with a person with COVID-19, they must quarantine and may not return until they meet the CDC's criteria for return to school—which currently provides that the individual should stay home for 10 days after his/her last contact with the person who has COVID-19.

The local health department has been notified of this situation. Based on guidance from the health department and other agencies, **All buildings** have been deeply sanitized and they will **not be closed**. District employees and students should continue to follow CDC guidelines and recommendations, and should continue to practice social distancing.

As a precaution, we encourage you to monitor your health, follow CDC guidelines, and contact your doctor if you develop COVID-19 symptoms.

The District is continuing to monitor this situation. We will provide additional information when permissible. We hope our students remains well.

Dear Valley School District Community,


I am writing to inform you that an employee at **Valley Local Schools** has tested positive for COVID-19. Due to privacy laws, we cannot disclose further information about the staff member. Whenever a person has a suspected or confirmed COVID-19 case, they must quarantine per the CDC and local health department guidelines and may not return until they meet the CDC's criteria for returning to school.

The local health department has been notified of this situation. We are asking the health department to assist in conducting contact tracing to identify individuals who had close contact with the staff member who tested positive. If your child had close contact with the staff member, you will be contacted by the health department and/or the District and provided instructions for self-care and any necessary quarantine period. Based on guidance from the health department and other agencies, **Valley Local Schools** have been deeply sanitized and are **not closed**. District employees and students should continue to follow CDC guidelines and recommendations, and should continue to practice social distancing.

As a precaution, we encourage you to monitor your health, follow CDC guidelines, and contact your doctor if you develop COVID-19 symptoms.
