Interview Superintendent Candidates

Chairman Scully informed the candidates the interviews will be videotaped and posted on the school website and a hiring decision should be made within forty-eight hours.

The board conducted interviews with Brian Hilton, Lynne Peterson, Rob Osborne and Casey Klasna. The board recessed the meeting at 5:30 p.m. in order to attend the community meet and greet. The board reconvened at 6:15 p.m. to discuss the candidates' backgrounds. Chairman Scully closed the meeting as the individual's right to privacy outweighed the public's right to know.

The board reopened the meeting at 8:10 p.m. The board discussed health insurance, housing, and recruitment tools.

Trustee George made a motion to recess the meeting and reconvene on Wednesday, at

The board reconvened at 9:00 a.m. March 30th. Chairman Scully explained Trustee Coffman would be late as he was attending to an accident on the Virginia City Pass. Chairman Scully closed the meeting at 9:05 a.m. as the individual's right to privacy outweighed the public's right to know. The meeting reopened at 11:00 a.m. and was recessed to Thursday at 8:30 a.m.

The board reconvened at 8:30 a.m. March 31st and Chairman Scully closed the meeting as the individual's right to privacy outweighed the public's right to know. The meeting reopened at 9:00 a.m. and recessed to 10:00 a.m. The board reconvened at 10:00 a.m. Chairman Scully closed the meeting as the individual's right to privacy outweighed the public's right to know. The meeting reopened at 10:32 a.m.

Chairman Scully asked the board after reviewing all the pertinent information, what were their thoughts on the candidates? Trustee Inman said her top choice was Casey Klasna, Rob Osborne was second, Brian Hilton was third and Lynne Peterson was fourth. Brian Hilton lacked experience and three new administrators at the same time would be tough. Trustee Lake agreed with Trustee Inman. Trustee Coffman said we had a qualified group and they all interviewed well, with that, his choice was Casey Klasna. Trustee George and Chairman Scully agreed on Mr. Klasna. Chairman Scully informed the board Mr. Klasna has a three-year contract with Terry and we would need to be sure they would release him from his contract which has one year remaining.

Trustee Inman made a motion to offer Casey Klasna a two-year contract beginning July 1, 2016 at \$90,000 per year and adjustments as needed for full family health coverage, five personal days, a district provided cell phone, housing up to three years at \$575 per month and possible moving expenses. Trustee Coffman seconded the motion. All members present were in approval.

Trustee George and Coffman will meet with Brian Hilton on Thursday morning and Chairman Scully will call the other candidates and contact the board chair from Terry to discuss Mr. Klasna's release from his contract.

As there was no other attention for the board the meeting was adjourned at 10:45 a.m.
