EXTRACURRICULAR ACTIVITY TAX CREDIT CONTRIBUTION FORM

Arizona State Law (A.R.S. 43-1089.01) allows taxpayers to donate up to \$400 per household (\$200 for single taxpayers and head of household; \$400 for a married couple filing a joint return) of their state taxes to public schools to support extracurricular activities. For example, if you owe \$1000 in Arizona state taxes and you donate \$400 to GUSD for extracurricular activities*, you may subtract the \$400 from your tax bill and pay only \$600. You also reduce the costs of school sponsored activities for students. You do not have to have a student at GUSD or any other public school to take advantage of this tax break.

Tax credit donations may not be used to purchase classroom supplies. Tax credit donations are non-refundable.
