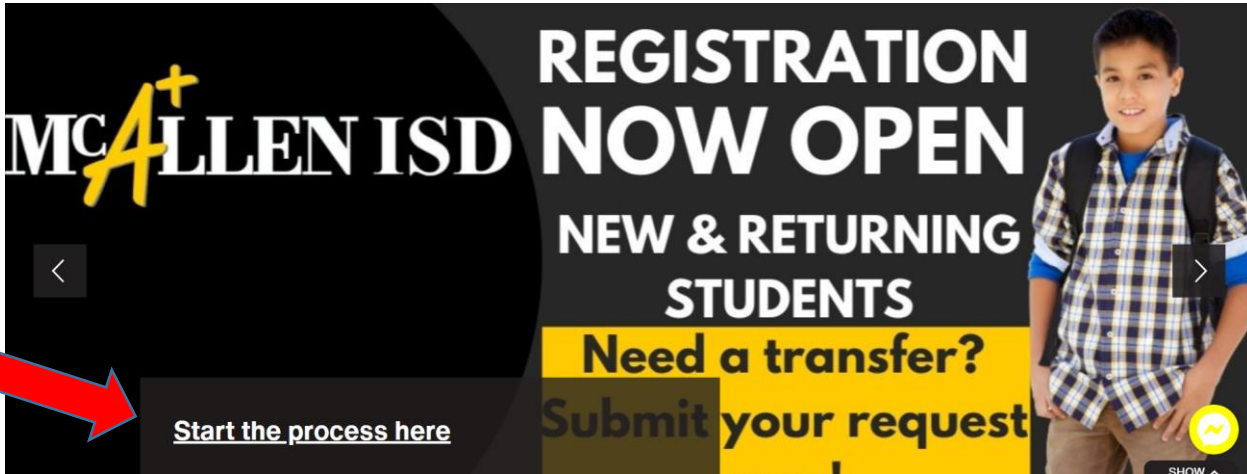

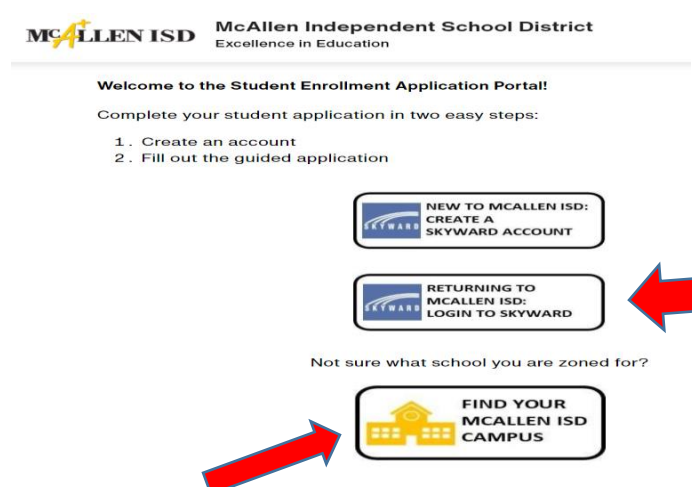

Welcome to the 2021-2022 Student Registration

Congratulations Your Child is Pre-Registered for the 2021 2022 school year!

Now, we simply need you to update your contact information (important for emergency notifications) and your student's records (Health, Residency, Transportation, Public Information, etc.) by clicking on items #1-7 (column on your right). For item #7, a verification screen will appear, click on the "Submit Returning Student Registration 2021-2022" button to finalize the process.

For further information, assistance with username & password, or if you require access to a computer to complete your Online Registration process, please contact your campus during regular business hours, Monday - Friday from 8:00 am to 3:30 pm.

Registration - Residency Requirement:
McAllen ISD is an open enrollment district and we welcome any students that reside in the State of Texas. As provided in Section 25.001 of the Texas Education Code, you may be liable to the District if you knowingly provide false information. Falsifying information may also subject you to penalties under Section 37.10 of the Penal Code. By completing the registration, you are attesting that the information provided is true and correct. As a guardian, you will also assume the responsibility of notifying the school when there is a change in your residential address or phone number.

Electronic Signatures:
Under guidance from the Federal Electronic Signatures in the Global and National Commerce Act, before you may electronically sign these Registration Forms, you must be provided with the following information and you must agree to the following statements.

- * I understand and agree that my electronic signature is the equivalent of a manual signature and that others may rely on it as such in connection with all agreements I may enter.
- * I further acknowledge and agree that it is my obligation to immediately advise the school district of any change in my electronic address (i.e., email address).
- * I further acknowledge and agree that it is my obligation to immediately advise the school district in the event that I withdraw my consent to this Electronic Signature Agreement.
- * I acknowledge and agree that the individual electronically signing these Registration Forms is the same individual that the Skyward account has been created for or is someone authorized to submit these Registration Forms by the person whose name is on the Skyward account.

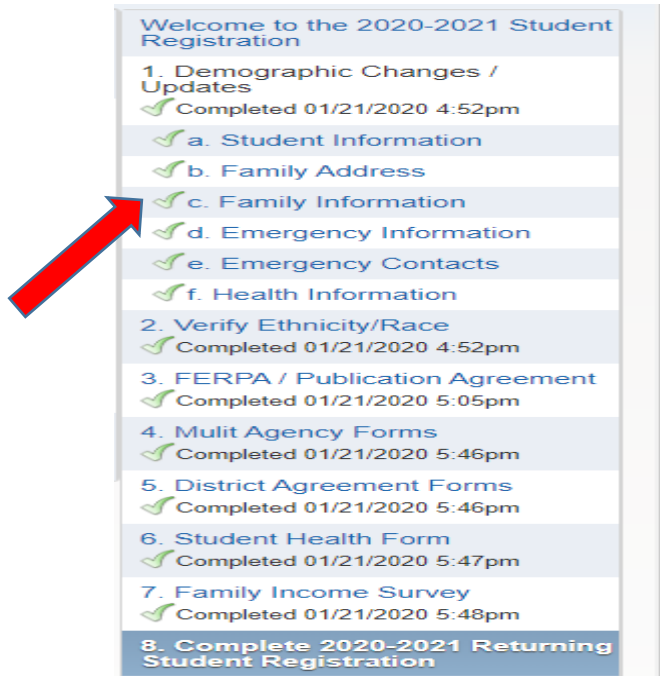
