Dear NTCC Students and Families:

We are excited to announce that *PS Bank is once again sponsoring a K-12 Career & Technology Scholarship for students in all NTCC Programs of Study for the 2023-2024 school year!* In the past three years, NTCC students received more than \$300,000 in program materials.

- This scholarship provides recipients with supplies associated with successful participation in the Program of Study and transition into their chosen career fields, including tools, equipment, uniforms, safety gear, and industry certifications. Items vary by program and examples include steel toe boots, mechanic tool sets, cosmetology kits, stethoscopes and scrubs, chef's hats and jackets, and program-specific tools. Students will receive the items, not a monetary award.
- Families with an adjusted gross income less than & up to \$105,000 plus \$18,500 for each dependent listed on the 1040 tax return may be eligible. Example: A family with 2 children may qualify with an adjusted gross income less than & up to \$142,000.
- Please see the attached application information. <u>New and returning students</u> must apply to be eligible for this year's scholarship.
- Even if you received the scholarship last year, you MUST apply again to be considered.
- You can apply now! Applications will be processed on a first come, first served basis. If you plan
 to apply for the scholarship, you may delay purchasing program materials until you know
 whether you've received it.
- The deadline for 2023 applications is Friday, September 8th.




FIRST COME, FIRST SERVED. APPLY NOW!

To be eligible for this scholarship, students must reside in Pennsylvania and in a household with an adjusted gross income of up to \$105,000 plus \$18,500 for each dependent listed on the family federal 1040 tax return.

Students in 9th through 12th grade in the 2023-2024 school year are eligible. The number of scholarships is limited.
