### Meal Charge Policy

The Big Sandy School District does not allow meal charges, except during the first 10 days of school.

The District complies with Federal USDA policies on meal charging and debt collection. All meals and charges must be paid back to the Big Sandy School District. Uncollected meal debt will be sent to collections per Federal guidelines.

### Zero-Balance Prevention

The Big Sandy School District will notify all negative accounts via email or USPS invoice. Bills for negative balances will be sent the 15<sup>th</sup> of each month.

For current balance, parents/guardians may contact the school food account manager via email or telephone. Contact information is available at [www.bigsandy.k12.mt.us](http://www.bigsandy.k12.mt.us).

If behavior patterns develop with students who are not able to maintain a positive balance, the school food account manager will discuss this problem with the superintendent who will determine the best solution for the student.

All balances due must be paid in full by the last day of enrollment for that student for the current school year. If there is economic hardship the parent/guardian can meet with the Business Manager on the possibility of a repayment program.

### Adult Meals:

Adults are not allowed to charge meals or A la Carte purchases, as per USDA policy regarding school food service use of Federal NSLP funds.
