## Outdoor Contact Sports Opt-In Form

Updated 2/16/2021

This form is to be used by a school located in a county designated as High Risk or Extreme Risk to notify of its intent to opt in to offer outdoor contact sports for the 2020-21 school year in accordance with the Governor's February 10, 2021 update to Outdoor Contact Sports Guidance. Once final, this form will be posted to a school or district website and a link to it will then be sent to ODE.

*In Lower Risk and Moderate Risk counties, practices and games for outdoor contact sports, including high school football, can resume following health and safety guidance to be issued by the Oregon Health Authority.*

*In High Risk and Extreme Risk counties, where COVID-19 remains more widespread, schools and other sports organizations can opt-in to resuming outdoor full contact sports with additional protocols in place. In such counties, sports organizations must offer on-site responsive testing for symptomatic individuals and close contacts, contact information for contact tracing, and a waiver identifying health and safety risks and a commitment to isolation and quarantine if exposed to COVID-19. Schools in Extreme and High Risk counties must also have at least limited in-person instruction occurring, with the goal of achieving hybrid or full in-person instruction for students this school year. Schools must also be in compliance with state guidance for COVID-19 testing.*

Protocol for Screening Participants, Coaches, Officials, Staff Members, etc. for football at Harrisburg High School

- 1) Attestation/Affirmation from coaches, officials, staff that they are not experiencing symptoms.
  - a. Recorded on a daily log maintained by the designated person in the athletic/coaches office (utilizing the sample contact tracing forms listed above).
  - b. Daily logs saved & stored for a 4 week time period in the athletic office.
  - c. Bus drivers will be responsible to keep a log of passengers and screening.
- 2) Student Athletes will undergo a visual screening or will have an attestation from parents that they are not experiencing symptoms that day.
  - a. Entry Plan with designated screeners who maintain the contact logs for entry
    1. Football coaches and staff will perform visual screening as players show up to practice and during practice.
    2. Players riding the bus will be visually screened either upon entry or departure from the bus.
  - b. Entry contact logs stored in a 3 ring binder for the entire season and 4 weeks after season ends
- 3) If a student athlete has any of the primary symptoms from the visual screening, they will be sent for a COVID-19 screening in the designated area. Daily records of student athletes who were screened in the designated area will be kept by the office staff or designated staff.
- 4) Primary Symptoms for screening taught to all staff.

## Contact Information for Contact Tracing

- a. Cough
- b. Fever/chills
- c. Shortness of breath/difficulty breathing
- d. COVID-19 symptoms may also include the following, but these are less specific and not recommended as criteria for exclusion from school alone: new loss of taste or smell, headache, muscle or body aches, nausea or vomiting†, diarrhea†, fatigue, congestion or runny nose.
- e. Some Chronic conditions may cause some of these symptoms. Staff will work with parents and health professionals. (Examples include allergies or asthma)

## Student-Athlete Waiver

### OHA Requirements

- The school must have a waiver completed for each student-athlete prior to outdoor contact sports participation identifying health and safety risks and a commitment to isolation and quarantine if exposed to COVID-19.
