Whereas on January 22, 2021, the Governor and the New York State Health Department authorized schools to operate certain higher-risk winter sports effective February 1, 2021 and only as permitted by local county health departments and;

Whereas, the New York State Department of Health subsequently issued updated guidelines for the operation of Sports and Recreation related to higher-risk winter sports and;

Whereas the NYSPHSAA association issued revised guidelines for Return to Interscholastic Athletics for the 2020-21 season and;

Whereas, on January 28, 2021 the Rensselaer County Executive Steven F. McLaughlin and Public Health Director Mary Fran Wachunas approved schools within Rensselaer County to operate higher risk sports and;

Whereas, the Superintendent has indicated that all New York State, Rensselaer County and league health and safety requirements will be implemented during all practices and games;

Now therefore be it declared that, based on the recommendations of the Superintendent of Schools, the Board of Education of the Brunswick Central School District is hereby approving the operations of the following interscholastic sports for the 2021 winter season:
