Item V: **COUNSELOR'S SPOTLIGHT:** Show your child how to become a more confident test-take
Test anxiety often comes from self-doubt. And it can affect test outcomes. If your child doesn't think he will succeed, he probably won't. To build your child's confidence: **1) Remove the pressure.** Tell your child that tests simply show the teacher what he's learned so far, and what he may need help with. **2) Avoid last-minute panic.** Your child should begin to review and study days before the test. **3) Teach efficient studying.** Help your child focus on the material he hasn't yet mastered. **4) Encourage positive self-talk.** He should tell himself that he is prepared to be successful. **5) Help your child visualize success.** Have him close his eyes and picture himself knowing the answers. PRE-K & KINDERGARTEN REGISTRATION

Information Sheet for the 2021-2022 school year

PRE-K Registration: (child must be 4 years old by September 1, 2021)

STUDENTS WHO RESIDE IN MARION COUNTY: Pre-Kindergarten registration is scheduled for Monday-Friday, FEBRUARY 22 - FEBRUARY 26 from 8:30 am – 2:00 pm. The registration form, along with the following items, are to be submitted when registering. Please **bring in a copy of the following items that the school may keep:** 1. A certified copy of your child's birth certificate. 2. His/her social security card. 3. His/her immunization record (FORM 3231). 4. A copy of his/her Eye, Ear, and Dental exam (FORM 3300). 5. Parent and child's proof of residency- See Below. 6. (If Applicable) Verification of Medicaid, Food Stamps, SSI, Well Care or proof of income. NOTE: The registration form can be picked up from the school or found on the school system **website: www.marion.k12.ga.us** under NEWS.



KINDERGARTEN Registration: (child must be 5 years old by September 1, 2021)

KINDERGARTEN STUDENTS WHO RESIDE IN MARION COUNTY: Kindergarten registration is scheduled for Monday, FEBRUARY 22 - FEBRUARY 26 from 8:30 am – 2:00 pm. If your child is currently in the LK Moss Pre-K program he/she will automatically be placed on the kindergarten list for next school year. (No need to register.)

If your child is enrolled in HEAD START and is eligible to attend Kindergarten next school year, you WILL NEED TO REGISTER him/her. When registering, bring these items with you to complete the child's registration process. Please **bring in a copy of each item listed below that the school may keep.**

*** FIRST TIME ENROLLEES IN MARION COUNTY MUST PROVIDE A COPY OF THE FOLLOWING WHEN ENROLLING A STUDENT:**

1. A certified copy of your child's birth certificate.
2. His/her social security card.
3. His/her immunization record (form 3231).
4. A copy of his/her Eye, Ear, and Dental exam (form 3300).
5. Parent and child's proof of residence

PROOF OF RESIDENCY REQUIREMENT

Proof of residence is required when a student initially enrolls in a Marion County school and whenever a change of residence occurs. LK Moss Elementary School will accept the following records as proof of residency: A lease or rental agreement consisting of written evidence that the agreement is valid and current, and two current utility bills or verification letter from two of the following utility companies: gas, electric, water, sanitation or cable company. Rental agreements must identify the parent/ guardian as the tenant of record fiscally responsible for the residence listed in the agreement. Parent/Guardians listed as occupants of a stated residence are not considered tenants of the property for the purpose of enrollment. All records must include the name and street address of the parent/guardian and service addresses must be plainly visible in any utility document provided as proof; OR current residential property tax statement, settlement statement, homestead exemption notice, or property deed, and two current utility bills or verification letter from either the gas, electric, water, sanitation or cable company. Parent/Guardians not listed in ownership documents willing to provide evidence of their legal relationship to the owner shall be permitted to use those service documents as an authorized representative of the titleholder. All records must include the name and street address of the parent/guardian and service addresses must be plainly visible in any utility document provided as proof; OR a Marion County Schools Affidavit of Residency. All such documents must be in the name of the student's parent/legal guardian and must consistently identify that individual with the property address of the residence.
