1. Call to Order: Chair Carr called the meeting to order at 6:30 p.m.

Superintendent Charette stated, in accordance with An Act to Implement Provisions Necessary to the Health, Welfare and Safety of the Citizens of Maine in Response to the Covid-19 Public Health Emergency as enacted to read Sec. G-1 MRSA Subsection 403-A Public proceeding through remote access during declaration of the state of emergency due to Covid-19 this business meeting is being held with a mix of in person and virtually, through zoom. The meeting is being recorded and will be posted on the maranacook.org YouTube channel.

This meeting's public comment portions are Item 3, and during the budget discussion, Item 8f. We respectfully ask that the virtual audience with the exception of the board members mute their microphones. There is a chat box feature in zoom that will only be used during the public comment portion of the agenda. If you have questions or comments we respectfully ask that you contact the central office or email the superintendent or any board member and an answer will be provided as soon as possible. We ask for the public's patience during these highly unusual circumstances. Attendance and all votes will be done through roll call.

2. Student Representative Reports:

Middle School student representatives Cooper Tarbuck, and Rocco Scott reported on team projects, and school wide events.

Superintendent Charette reported that high school student representatives Claire Holman and Morgan Boynton are both at a ski meet and are unable to report this evening.

- 4. Additions/Adjustments to the Agenda by Board and/or Superintendent:

David Twitchell requested a discussion about the student petition/letters the board received. This will be item 6h., student petition discussion.

5. a. Reports:

Superintendent Charette and Dr. Conway responded to questions about the Board reports regarding the Dual Enrollment Program and concerns about the lack of transportation. Regarding the transportation issue, Superintendent Charette reported all the buses are full except for the Wayne buses, but we have 11 drivers and several vacant positions. Truancy numbers were updated for February, with 1 new truancy at the high school level.

Superintendent Charette introduced Sarah Morrill, the new Health Center Director.

b. Committees:

Patty Gordon reported on the most recent Policy Committee meeting. There are 2 policies included for first readings: BEDL and JGAB. Two other policies are ready for first readings and will be presented at the April 7th meeting. Any comments or suggestions on the first reading policies should be forwarded to the Superintendent or a Policy Committee member prior to the next meeting. The Policy Committee requested the Principals attend the March 16 meeting for a discussion on Policy JICJ, Student Use of Cell Phones and Other Electronic Devices.

6. Action Items:

a. <u>Approval of Minutes of February 24, 2021 Meeting</u>

MOTION by Brotherlin, second by Wright to approve the Minutes of February 24, 2021 as presented.

Roll Call Vote – Motion Carried: 11 in favor, 0 opposed, 1 abstained (Tobin)

b. <u>Acceptance of Donations</u>

MOTION by Brotherlin, second by Wright to accept the donations as presented. **Roll Call Vote – Motion Carried**: unanimous

c. <u>Consideration of overnight trip – High School, Hidden Valley Nature Center, Jefferson,</u>
Maine, March 13-14, 2021

MOTION by Brotherlin, second by Wright to consider the overnight trip to Hidden Valley Nature Center in Jefferson, Maine, as presented.

High School teacher Robyn Graziano reported the Outdoors Nature Team was awarded this trip through the Trails Project. Ten students are planning to go on the trip and they have organized the meals, how they will sleep and are excited to learn how to make a shelter for sleeping. There is also a warming hut available if they get too cold.

Roll Call Vote – Motion Carried: unanimous

d. <u>Consideration of Approval of Facilities Bond Projects</u>

MOTION by Brotherlin, second by Wright to accept the recommendation of the Facilities/Transportation Committee and approve the projects to be funded through the Facilities Bond as outlined in item 6d.

Superintendent Charette reported that these are projects that were reported on last week. There is approximately \$541,179.00 remaining in bond proceeds after these projects and 1 $\frac{1}{2}$ years remaining to use the funds. The IA updates and the labor costs to install the LED lights at the track/fields are not included, but those will be brought to the Board prior to the work being started.

Roll Call Vote - Motion Carried: unanimous

e. Consideration of Approval of 2021-2022 School Calendar

MOTION by Brotherlin, second by Wright to approve the 2021-2022 School Calendar as presented.

Discussion ensued about snow days versus remote learning days. Superintendent Charette reported that as long as we can provide meals for the students, we can use remote learning days. Snow days would be used for days following a weekend, or days where there are expected wide spread power outages. Should some families lose power and a remote day is called, the students would not be penalized for not having their work done or logging on to a class. Devices will be available for all students. The proposed calendar includes 5 emergency days and it would be up to the Superintendent to decide whether days are remote learning days or snow days. The proposed calendar has been reviewed by the Administrative Team and Staff Association.

f. Policy Second Reading – JJE, Student Fundraising Activities

MOTION by Brotherlin, second by Wright to approve the revision of Policy JJE as presented. **Roll Call Vote – Motion Carried**: 11 in favor, 0 opposed, 1 abstained (Bowie)

Question was asked about the extension for last year seniors to use their class funds since they didn't get Project Graduation. Is anything going to be done? Has that even been talked about? What about this year's seniors? Dr. Conway responded that the money is still there for the Class of 2020 and the events are to be planned by the students. The Superintendent added the extension for the Class of 2020 gives them 5 years to plan something. They need to contact Dr. Conway.

Dr. Conway added that regarding the Class of 2021, there has been an advisor meeting and a meeting with seniors and a meeting with senior parents is planned for next week.

g. <u>COVID Data Update</u>

Superintendent Charette shared a summary and data sheet that was recently updated. The District is doing very well right now.

h. Student Petition Discussion (addition to agenda)

David Twitchell stated he would like to give students an opportunity to speak at the March 10th, meeting. Last week the Board was assured that all schools were following protocols but the snapshot given in the petition/statements from this group of students' states things were not completely accurate. He would like to have assurances that we are listening to the students. He wants the Board to seriously think about whether we can do more to reassure that we are protecting everyone in the school community as thoroughly as we can.

Reminder was made that people are welcome to come to the Board and speak during citizens' comments to share their viewpoints with the Board.

7. Informational – upcoming meetings

8. Budget Workshop: last part of the budget workshop – miscellaneous accounts

a. Updates

Superintendent Charette reported no changes were made to the draft budget since last week and everything that is being presented tonight is included in the budget. He expects an update next week that will include some reductions. Regarding the Technology budget, he is working with Mrs. MacGregor; the figures are still fluid, but they will work together to move some of those costs to the ESSERF grant. Oil prices are a concern, so they will hold off on going out to bid. Another concern is the property and casualty insurance rates are projected to increase 18-24%. Normally we estimate 15% and adjust accordingly.

b. Co- and Extra- Curricular

There are no new requests, but the budget is up \$7,500 due to salaries, benefits, and workers compensation.

c. Transportation

The Transportation budget is up about \$42,872 which is partly due to salaries, benefits, and workers compensation. The budget also includes additional special education transportation costs for an out-of-district placement. There is also a need for a special education bus aid. The remaining increase is due to insurance increases. There are decreases in equipment and bus leases.

d. <u>Miscellaneous Cost Center/Accounts (Adult Education, Food Service, Health Center, Professional Development/Assessment/Curriculum, Systems Administration, Debt Service)</u>
Health Center - There are no new requests. The Health Center is funded through local funds, a state grant, and a Family Planning grant.

Adult Education – There are no additional requests. In the past, Mr. Vose's budget included a request of \$12,000 for the CDL program, but he has a little reserve in that budget, so he is not requesting the \$12,000 this year.

<u>Professional Development/Curriculum/Assessment</u> This portion of the budget brings the Director of Curriculum, Instruction and Assessment position back to full time (60% this year); includes funds for ALICE training, which has been done through RSC; for an overall increase of \$30,000.

<u>Food Service</u> – There are no new requests in this budget and no addition to local funding. <u>Systems Administration</u> – This line is up about \$49,000 due to salaries, school board liability insurance, ADS software, and dues and fees.

<u>Debt Service/Lease purchases</u> – This line is down about \$464,263, mostly due to the middle school and athletic fields bonds being paid off. The Superintendent noted that whatever the Board decides with technology will likely be through a lease.

e. Board Questions

Shawn Roderick expressed concerns regarding transportation. What have we looked at for options to fill the driver positions (bonuses, train people and pay for it if they stay X number of years)? Superintendent Charette responded that they have talked about these options. It would require the Board to commit a sum of money to do these things. He will bring a potential amount back to the Board for consideration.

Steve Vose added that he recently had a conversation with Transportation Manager Julie Greenleaf about this. It is not necessarily a shortage of school bus drivers, but the Board would need to make the monetary commitment. He and Ms. Greenleaf have talked about starting something locally, perhaps having driving students do some of their driving time along the bus routes, etc.

Kim Bowie asked about the request from John Harker last week and the consideration of setting aside a sum of money; Mr. Harker suggested \$5,000 for nutrition curriculum. Superintendent Charette responded this is not in this budget. The Board needs to consider whether this is something they wants to pursue. He will look into what Mr. Harker suggested.

Cathy Jacobs added that before the Board commits to any amount of money she would like to see what is already in the curriculum.

f. Citizens comments regarding budget

A citizen asked if the Board has thought about any alternative heat sources. The Superintendent responded we do have heat pumps in strategic places, but we can look at that further.

This contract comes due every 5 years with the current cycle ending June 30, 2021. We worked with Drummond Woodsum and Fayette to update the language in the contract. There are no substantial changes to the language and it meets all requirements set out in statute. This is not an exclusive contract but it is worth noting that we typically receive a bulk of the class size request to attend the Maranacook Community Middle School. The contract includes timelines if we would have to limit enrollment, provisions on Special Education, Transportation, and tuition payment. We have had a mutually beneficial relationship with Fayette concerning this contract and I recommend the Board approve the Contract for another 5 year period.

Sample Motion:

I move to accept the Contract for School Privileges grades 6 through 12 with Fayette as recommended by the Superintendent.

CONTRACT FOR SCHOOL PRIVILEGES

(Grades 6 through 12)

THIS NON-EXCLUSIVE SCHOOL TUITION AGREEMENT ("Agreement") is entered into as of June 30, 2021 (the "Effective Date"), by and between the Town of Fayette, a municipal school unit acting by and through its School Committee ("Fayette") and Regional School Unit No. 38, a school administrative unit acting by and through its School Board ("RSU 38") (individually, a "Party"; collectively, the "Parties").

RECITALS

WHEREAS pursuant to 20-A M.R.S.	§ 2701, the voters of Fayette voted at a town meeting duly

WHEREAS pursuant to 20-A M.R.S.	§ 2702, the voters of RSU 38 voted at a budget meeting
* *	, 2021 to authorize the RSU 38 School Board to
	school privileges for Fayette resident students in Grades 6
through 12 for a five-year term.	

NOW, THEREFORE, in consideration of the mutual premises and covenants contained herein, the Parties, intending legally to be bound, agree as follows:

1. Term; Termination.

- A. <u>Term.</u> RSU 38 agrees, for a period of five (5) school years commencing July 1, 2021 and ending June 30, 2026, to provide and make available educational services for Fayette resident students in Grades 6 through 12 (collectively, "Tuition Students"). As of the Effective Date, this Agreement supersedes in all respects the Contract for School Privileges dated May 19, 2015 between the Parties, which by its terms was to expire on June 30, 2021.
- B. <u>Termination</u>. Either Party may terminate this Agreement by giving the other Party notice of termination in writing at least two years prior to the effective date of termination. RSU 38 shall immediately file a copy of said notice of termination with the Commissioner of the Maine Department of Education ("MDOE") in accordance with 20-A M.R.S. § 5803.
- 2. Educational Services. RSU 38 agrees to provide Tuition Students with an educational program that meets all educational standards established by the MDOE. Educational program services shall be provided to Tuition Students on the same terms and to the same degree as those services provided to RSU 38 students in the same grades, except as otherwise provided in this Agreement. Without limiting the foregoing, Tuition Students shall be subject to the same policies and procedures regarding academic performance, behavior, and discipline as RSU 38 resident students in the same grades.
- **3. Non-exclusive Agreement; Limitation on Enrollment.** This Agreement is a non-exclusive school tuition agreement. On or before January 15 of each year, Fayette shall provide the

Superintendent of RSU 38 written notice of the names and grade levels of all Fayette resident students who are expected to enroll as Tuition Students in the following school year. The Superintendent of RSU 38 may limit the number of Fayette students that may become Tuition Students if the Superintendent of RSU 38 determines that such a limit is necessary to maintain an acceptable quality of service with existing personnel, buildings, programs, placements and other resources. The Superintendent of RSU 38 shall provide Fayette preliminary written notice of any such limit by March 1 and final notice no later than the date of the RSU 38 budget meeting (usually in May) held prior to the school year to which the limit will apply.

4. Special Education Students and Students with Disabilities.

- A. Special Education Services and Programs. RSU 38 shall provide all special education and related special education services for Tuition Students as required by an Individualized Education Plan ("IEP") prepared by each qualifying Tuition Student's IEP Team to the extent RSU 38 has an appropriate program or placement that meets the terms of the IEP and applicable requirements of Maine law and regulations. Decisions about whether RSU 38 can implement the terms of the IEP and whether RSU 38 has an appropriate program or placement for qualifying Tuition Student pursuant to the requirements of the IEP shall be made by RSU 38 in consultation with the Fayette Superintendent (or designee). In no event shall RSU 38 refuse to provide services set forth in the IEP except for Tuition Student removals of not more than 10 cumulative school days in the school year, when a Tuition Student has been properly expelled from RSU 38, or when RSU 38 has determined pursuant to this paragraph that the necessary program or placement does not exist. RSU 38 has no obligation under this Agreement to create new programs for qualifying Tuition Students.
- B. <u>IEP Team Meetings</u>. The Fayette Superintendent (or designee) shall represent Fayette for special education programming, supervision of the IEP Team process, and supervision of the evaluation process for Tuition Students. IEP Team meetings must be attended by the Fayette Superintendent (or designee who has written authority to obligate Fayette fiscal resources) when the IEP Team is considering an out-of-district placement, program change, or additional costs. In the event the IEP Team is unable to reach consensus on issues that are responsibility of the IEP Team, the Fayette representative at the IEP Team meeting shall make the decisions on those issues, subject to the due process rights of the qualifying Tuition Student's parents/guardians in relation thereto.
- C. <u>Consultation</u>; <u>Good Faith</u>. RSU 38 will work cooperatively with the Fayette Superintendent (or designee), and, upon request, will provide the Fayette Superintendent (or designee) with all information regarding classroom observations, performance, academic achievement testing, and functional behavior assessment components of a qualifying Tuition Student's evaluation process. The Fayette Superintendent (or designee) shall provide input to the RSU 38 Director of Special Education on the proper implementation of a qualifying Tuition Student's IEPs or any perceived deficiencies in IEP implementation. RSU 38 will consider such input in good faith and will respond in an appropriate manner consistent with the terms of this Agreement. In addition, RSU 38 will provide all Tuition Student IEP Team meeting notices, meeting minutes, and IEPs to the Fayette Superintendent (or designee).

- **5. Tuition.** Fayette agrees to pay RSU 38 the following tuition charges:
 - A. <u>Regular Program Tuition</u>. For each Tuition Student, Fayette shall pay the maximum allowable tuition rate established by MDOE pursuant to 20-A M.R.S. § 5804(1) (for elementary school Tuition Students, Grades 6-8) and 20-A M.R.S. § 5805(2) (for secondary school Tuition Students, Grades 9-12), or any successor provisions.
 - Special Education Costs. Fayette shall be responsible for all the costs of special В. education for qualifying Tuition Students, whether or not those costs qualify for state subsidy, as follows: The maximum allowable tuition provided in Section 5.A, above, expressly excludes expenditures for special education. Therefore, in accordance with MDOE's Maine Unified Special Education Regulation (MUSER), codified at 05-071 ch. 101, Section IV(4)(A) and (B) and Section XVIII, for each qualifying Tuition Student, in addition to the maximum allowable tuition provided in Section 5.A, above, Fayette shall be responsible for the actual costs of special education for qualifying Tuition Students, including special education transportation costs and costs for facilities modifications required to accommodate qualifying Tuition Students. For purposes of this Section 5.B, special education costs shall include support services (including, but not limited to, physical therapy, occupational therapy, speech and language therapy, psychological services/evaluations, and educational technician support as set forth in the IEP), costs of non-special education 504/ADA plans and services, any other allowable costs for the computation of special education tuition rates, and reasonable attorneys' fees incurred by RSU 38 in connection with disputes over delivery of special education services or 504/ADA plan services for Tuition Students.
 - D. <u>Career and Technical Education (CTE) Program Tuition</u>. For each qualifying Tuition Student, Fayette shall pay all costs that are attributable to a Tuition Student's enrollment in an RSU 38 career and technical education center program (currently, CATC), up to the maximum allowable tuition as provided in Section 5.A, above, and as further limited by 20-A M.R.S. § 5809 or any successor provision.
 - E. <u>Payment of Tuition</u>. Tuition and any other costs pursuant to this Agreement shall be billed to Fayette by RSU 38 in quarterly invoices, with a reconciliation after the MDOE sets final tuition rates and during the fiscal year in which the costs are incurred. Invoices shall be paid within thirty days of the billing date as required by 20-A M.R.S. § 5810.
- **6. Transportation.** Fayette is responsible for providing transportation services at its own expense for all Tuition Students, including transportation for special education students and students with disabilities. RSU 38 agrees to provide transportation services to and from RSU 38 schools and CTE programs for Tuition Students enrolled in a CTE program. The scope of transportation services provided by Fayette shall be determined by the Fayette School Committee.
- 7. **Records.** RSU 38 shall maintain Tuition Student records in accordance with applicable law and to the same extent as such records are maintained for RSU 38 resident students. To the extent permitted by law, Fayette shall be entitled to copy, review, and inspect the books and

records of RSU 38 related to Tuition Students, including special education students and CTE students.

8. Miscellaneous.

- A. <u>General Powers</u>. Nothing in this Agreement shall limit the authority of the Parties to exercise all the powers granted to them by state law over students, except as expressly provided to the contrary in this Agreement.
- B. Governing Law. This Agreement shall be governed by and construed in accordance with Maine law and federal law, and any provisions found to be inconsistent with Maine law and/or federal law shall be severable from the remainder of this Agreement. This Agreement shall incorporate any and all amendments to state or federal laws or regulations that require modification of the terms therefor.
- C. <u>Entire Agreement</u>. This Agreement embodies the entire agreement between the Parties and supersedes any and all prior agreements, arrangements, and understandings relating to matters provided herein.
- D. <u>Amendment; Successor Agreement</u>. Fayette shall notify RSU 38 in writing before July 1, 2025 if it desires to enter into a successor contract for school privileges upon the expiration of this Agreement. If such notice is given, or if the Parties desire to materially amend this Agreement, representatives of the Parties shall promptly meet to discuss the terms of a materially amended or successor agreement for presentation to their respective voters to the extent required by 20-A M.R.S. §§ 2701-2702.
- E. <u>Notices</u>. Any notice, demand, or request required or permitted to be given under the provisions of this Agreement shall be in writing and shall be deemed to have been duly received on the date of personal delivery or three days after the date of mailing if mailed by registered or certified mail, return receipt requested, to the following addresses, or to such other address as either Party may request by notifying in writing the other Party to this Agreement.

- F. <u>Counterparts</u>. This Agreement may be executed in one or more counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same instrument.
- G. <u>Filing with Commissioner</u>. The Parties shall file a copy of this Agreement with the Commissioner, as required by 20-A M.R.S. § 2703(1)(E).


SUBJECT: Consideration of District Network Improvement Contract
