Mrs. Janet Stumbaugh, Asst. Superintendent for Curriculum, reported on the End of Course scores. They were better, but need to improve. Next year the Math Coach will spend one day at the high school. Teachers to utilize the USA Test Prep had better scores. Overall the scores were a mixture of "ups and downs" so she does not know how it will impact the HS MSIP.

4. Old Business

a. Mr. Woods moved to approve the MSBA District Policy changes and Policy GBCA. Seconded by Mr. Queathem. The motion passed. **VOTE was 6-0**

5. New Business

- a. MSBA Monthly Report was viewed. It included information regarding the Governor's veto of HB253, extension of the Sunshine Law exemptions, MSBA sponsoring a trip to D.C this summer for advocacy work, the 14th edition of the Educator's Desk Reference is on the MSBA website, and registration is now open for the annual MSBA Conference in October.
- b. Mr. Queathem made the motion to amend all projected 2012-13 expenditures to actual 2012-13 expenditures seconded by Mr. Muchow. The motion passed. **VOTE was 6-0**

e. Mr. Sellenriek made the motion to set the following breakfast/lunch prices for the 2013-14 school year.

Regular Student Breakfast (all buildings) - \$1.10 Reduced Student Breakfast (all buildings) - \$.30 Regular Student Lunch (HS/MS) - \$1.60 Regular Student Lunch (Elem.) - \$1.50 Reduced Student Lunch (all buildings) - \$.40 Adult Breakfast - \$1.35 Adult Lunch - \$2.10

- f. Mr. Woods made the motion to add \$1,000.00 to the base of the Certified Salary Schedule and allowing steps for total new money of 3.49%; add 2.03% to each base amount on the Classified Salary Schedule and allowing steps for total new money of 3.49%; and providing 3.49% increase to staff not on a salary schedule. Mr. Queathem seconded the motion. The motion passed. **VOTE was 6-0**
- g. Mr. Janet Stumbaugh reported on the Wellness Committee meeting. One of the things that need to be addressed is the PE time for elementary students. The committee would like to discuss revisions with building administrators and then ask the Board to take action.
- h. Mr. Woods made the motion to approve contracts with Nancy Blaue and Barb Welschmeyer for PAT services and pay for their training, \$195.00 each, for the 2013-14 school year. Mr. Sellenriek seconded the motion. The motion passed. **VOTE was 6-0**
- i. Mr. Queathem made the motion to let fuel bids for transporting students for the 2013-14 school year seconded by Mr. Finke. The motion passed. **VOTE was 6-0**
- j. Brandon Dake and Jason Hainline from Dake Wells Architecture reported on the schematic plans-which are about 90% finished and pricing for construction for the four buildings in the District. Today, the design development cost estimates are:

Construction Costs w/o Jonesburg Gym .	\$13,526,758
Jonesburg Gym (possibly FEEMA money))\$1,418,219
Contingency costs-change orders (10%)	
"Soft" costs	
Total Project Cost	\$18,403,474

This puts the project over budget \$2,000,000. Discussion was held regarding if the District could absorb that amount or make cuts. The Board felt we needed to keep with what was said on the ballot and keep the list of priorities made by the committee and previously approved by them.

 - He met with Fischer Track Company regarding the new track project and showed them
 a picture of the what it would look like when finished. Due to weather constraints, and
 other projects ahead of ours, the track probably will not be completed until September
 or October. However, it will be within the budget.
