- d. Superintendent Gray and Ross Kidwell updated the Board on the construction project:
  - The floor slab is poured at the High School.
  - The footing and short walls should be completed tomorrow
  - The Steel should be delivered at Montgomery City Elementary tomorrow so they should be able to start pouring the floor
  - Outside block walls at JB are being laid as well as inside walls started.
  - Blockwork should start on the High School next week.
  - Asbestos work is completed at the Middle School and they are working on Montgomery City Elementary.
  - Not a great deal of change orders so far
  - May be able to use sink at Montgomery City Elementary in the Vo-Ag Meats Room.
  - Lights on the second field are up and adjusted as well as changing out burnt out bulbs on the other field.
  - Concession Stand walls are up and will set trusses tomorrow. They will transfer the 5-ton air conditioning unit from MCE to the Concession Stand to save money.
  - While everything is out of the room, the Middle School Library is going to be remodeled.
  - The two Science Labs at the High School are being remodeled this summer. The chemistry lab will be remodeled next year.
  - The Football Bleachers are rusting and the roof on the field house where the baseball stuff is stored is caved in. In order to fix it properly it will take around \$80-\$85,000. This is something that would be done next summer.
  - Jack Sewell out of Wellsville has submitted a bid of about \$25,000 for fencing around the track.
  - Bids will be ready to "let" on the parking lot out front of the Middle by the end of next week.
  - Mr. Gray is currently writing bids for Baseball Standards and Pepsi and Coke
  - Don't' know for sure what is causing the old on the carpet on the North end of Jonesburg Elementary Building.

## 6. Reports

- a. The CSIP reported was tabled to next month. Scores are not yet back.
- b. Mrs. Stumbaugh reported on Summer School numbers. The high school had 97 students with a 97.7% attendance; Middle School had 28 students with 87.1% attendance; and Elementary had 163 students with 94.5% attendance.
