In response to Governor Brown’s guidance for schools to prepare to resume in-person instruction to students by February 15th, McKenzie School District assembled a committee made up of community stakeholders including certified, classified, and administrative staff, parents, local health professionals and community members. This group worked to weigh district readiness for reopening in light of not only COVID-19 but also the wildfire that burned through our community and around our campus. To inform their work, the committee surveyed district families around their likelihood to return as well as their questions and concerns. The group recommended resuming in-person instruction targeting March 15th to begin welcoming back students. The tentative rollout plan is to welcome grades 1, 2 & 3 March 15th, Pre-K, Kinder, 4, 5 & 6 March 29th, Grades 7-12 are targeting return to campus in the weeks following the elementary grades. This committee continues to meet and support planning for and implementing plans to safely return students and staff to campus.

Previously, under the Emergency Waiver for in-person instruction due to the impact of wildfires in our community, McKenzie School District has provided students on-site instruction at our main campus, using both our elementary grades building and our High School Building. These facilities space and layout allow us to serve students while meeting the health and safety requirements provided in RSSL. Instruction continued through our CDL model; however, in person opportunities will allow us to better support internet connection, academic support, and social-emotional needs of our displaced students.

McKenzie School District has targeted March 15th as the date to begin resumption of On-Site learning with grades 1, 2, & 3. The intention to add grades PK, K, 4, 5 & 6th the week of March 29th. Grades 7-12 will be added in subsequent weeks informed by local health metrics and the experiences of the elementary grades if deemed safe and practicable.

We continue to monitor District specific and Lane County health data as we begin to add additional grade levels.

The McKenzie School District follows the published Communicable Disease Guidance from the Oregon Department of Education and the Oregon Health Authority.

We are working directly with Lane County Public Health and Kate Blair will be notified of any case we hear about through our community, as well, she informs us of confirmed and presumptive cases connected to our school communities.

We continue to work together with Lane County Public Health and our Reopening Advisor from Lane ESD to inform our blueprints, Disease Management Plan, and procedures as guidance and new research is provided by ODE and OHA

Superintendent Lane Tompkins updates the weekly report to ODE to report instructional model and the number of students/cohorts on campus.

In the case of student or staff illness, ODE's COVID Scenarios guide and consultation with Lane County Public Health will be used to inform communication and isolation, quarantine, and shift instructional models for individuals, cohorts, or the entire school.

Utilizing both online and on-site trainings (as allowable and feasible), all staff (classified and certified) will be trained on the components of this document as well as our policies and plans for managing the COVID pandemic.

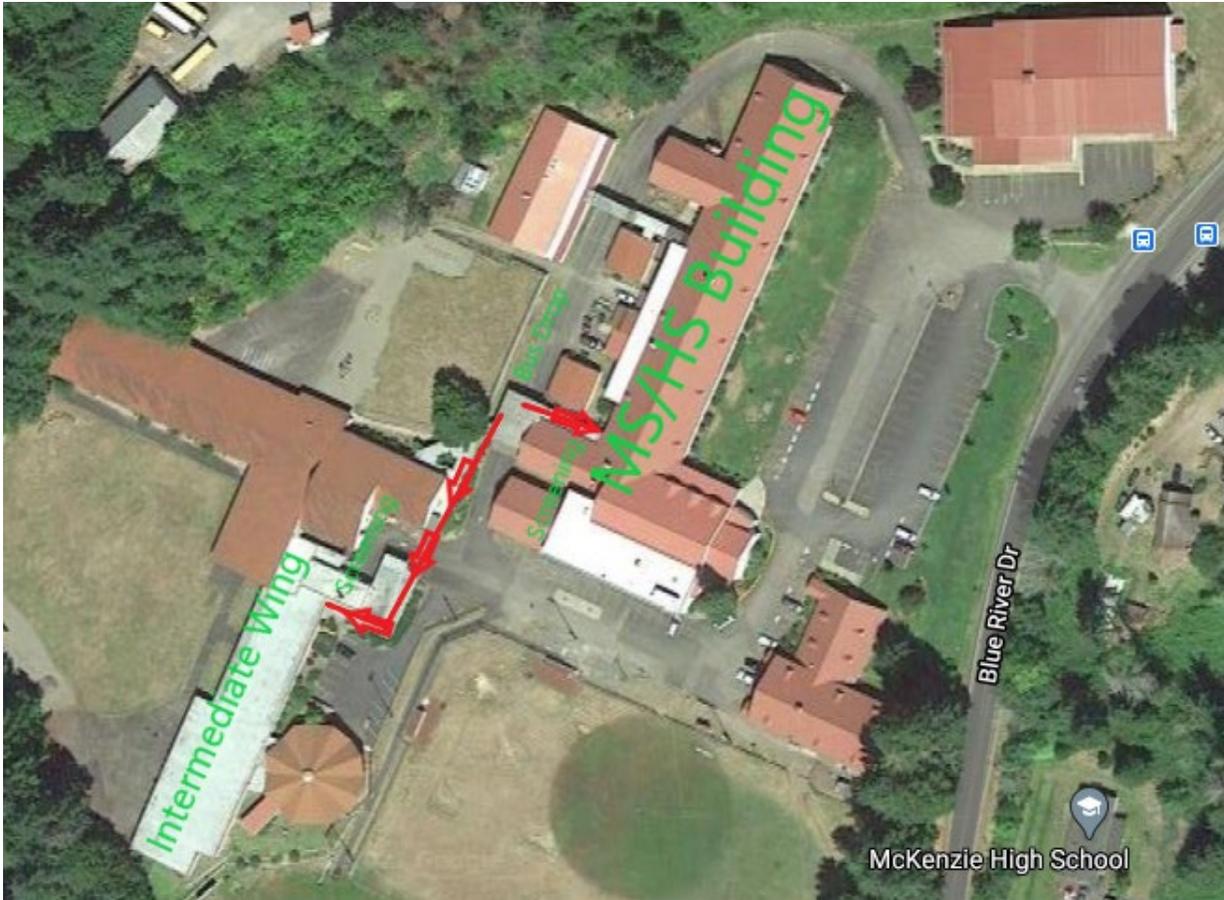
Building administrators and department supervisors will be responsible to establish, implement and enforce physical distancing requirements.

Anonymous safety concern drop boxes are located in both copy rooms. These will be monitored by administration and discussed in Safety Committee meetings. A web form will be posted on the District website for anonymous safety concerns from staff, students and families.

Screening

- Students grades K-6 will enter the elementary building through the Intermediate wing doors of the elementary building nearest the Elementary Office. Students will be screened upon entering the building. Students grades 7-12 will enter the high school building through the west door of the building near the "Old Gym" on the backside of the building, Students will be screened upon entering the building. Upon screening, students will proceed directly to their designated learning space. Staff will be assigned to screen students prior to entering the learning spaces.



- When the screening indicates that a student may be symptomatic, the student is directed to the elementary office where the staff will follow the isolation and screening protocols identified in the district's COVID-19 plans and will follow directions provided by the Lane County Health Department.
- Hand sanitizing stations will be placed by each entrance prior to student entrance to classes, or students will utilize classroom handwashing stations to wash hands.

Isolation: A separate office space in the Elementary building has been designated as an isolation room. The room shall be staffed when occupied. In the case of isolation, all occupants in the room shall wear appropriate PPE unless health conditions prohibit such use.

Reporting to LPHA: Lane County Public Health will be notified in the case of a student or staff isolated for possible symptoms.

Contract Tracing

Daily logs for student cohorts shall be created and stored for each student cohort. Logs will be collected by Lorinda Marcy, Elementary Secretary and stored in a locked cabinet for a minimum of 4 weeks. Logs shall be shared with the Lane County Health Department and may be used as needed for contract tracing purposes.

Logs shall include:

- Child's name
- Drop off/pick up time
- Parent/guardian name and emergency contact information shall be maintained and accessed via eSchool SIS. Lane County Health Department shall be granted view only access to student demographic information for contact tracing purposes.
- All staff/adults who come into contact with each child.
 - All staff, including itinerant staff, substitutes, guest teachers, and essential visitors, will be required to sign in and screened upon arrival. Sign-in logs shall include: email address, date, first and last name, arrival and departure times, building/office, location of activities, and an attestation regarding COVID-19 exposure. This information will be collected and stored in a Google form for contact tracing purposes.

Disinfection: Disinfection shall occur daily in each learning space. Restrooms are not accessible by the public and will be cleaned twice per day. Door handles and surfaces shall be in accordance with Lane County Health Department recommendations for cleaning and sanitizing will be followed and the plan will be revised accordingly as needed.

Outbreak Plan: In the event of an outbreak, McKenzie School District will work directly with the Lane County Health Department to implement the outbreak plan.

Requirements for 1b. HIGH-RISK POPULATIONS

- Serve students in high-risk population(s) whether learning is happening through On-Site (*including outside*), Hybrid (partially On-Site and partially Comprehensive Distance Learning models), or Comprehensive Distance Learning models.

Medically Fragile, Complex and Nursing-Dependent Student Requirements

- All districts must account for students who have health conditions that require additional nursing services. Oregon law ([ORS 336.201](#)) defines three levels of severity related to required nursing services:
 - Medically Complex: Are students who may have an unstable health condition and who may require daily professional nursing services.
 - Medically Fragile: Are students who may have a life-threatening health condition and who may require immediate professional nursing services.
 - Nursing-Dependent: Are students who have an unstable or life-threatening health condition and who require daily, direct, and continuous professional nursing services.
- Review [Supplemental Guidance on Community and Health Responsibilities Regarding FAPE in Relation to IDEA During CDL and Hybrid](#).
- Staff and school administrators, in partnership with school nurses, or other school health providers, should work with interdisciplinary teams to address individual student needs. The

school registered nurse (RN) is responsible for nursing care provided to individual students as outlined in ODE guidance and state law:

- Communicate with parents and health care providers to determine return to school status and current needs of the student.
- Coordinate and update other health services the student may be receiving in addition to nursing services. This may include speech language pathology, occupational therapy, physical therapy, as well as behavioral and mental health services.
- Modify Health Management Plans, Care Plans, IEPs, or 504 or other student-level medical plans, as indicated, to address current health care considerations.
- The RN practicing in the school setting should be supported to remain up to date on current guidelines and access professional support such as evidence-based resources from the [Oregon School Nurses Association](#).
- Service provision should consider health and safety as well as legal standards.
- Appropriate medical-grade personal protective equipment (PPE) should be made available to [nurses and other health providers](#).
- Work with an interdisciplinary team to meet requirements of ADA and FAPE.
- High-risk individuals may meet criteria for exclusion during a local health crisis.
- Refer to updated state and national guidance and resources such as:
 - U.S. Department of Education Supplemental Fact Sheet: Addressing the Risk of COVID-19 in Preschool, Elementary and Secondary Schools While Serving Children with Disabilities from March 21, 2020.

 - OAR 581-015-2000 Special Education, requires districts to provide ‘school health services and school nurse services’ as part of the ‘related services’ in order ‘to assist a child with a disability to benefit from special education.’

All staff and students given the opportunity to self-identify as vulnerable or living with a vulnerable family member.

Staff

- Staff who are unable to perform their job on-site due to a serious health condition or disability, will have the option of taking appropriate leave, or may be reassigned to perform tasks without in-person contact, if appropriate and reasonable.
- Classified staff members may be assigned to support on-line instruction.
- Certified staff members may be assigned to online primary instruction as lead teacher or supporting teacher per grade band.

Students

- All students identified as vulnerable, either by a physician, or parent/guardian notification, will have access to comprehensive distance learning.
- Students who experience disabilities will continue to receive specially designed instruction.
- Students with language services will continue to receive English Language Development instruction.
- Students who require nursing services will be contacted by the district office to determine return to school status and any other health care considerations in coordination with Lane ESD.

Visitors/Volunteers

- Visitors/Volunteers will be unable to work in schools, or complete other volunteer activities that require in person interaction unless they are deemed as essential personnel. All visitors/volunteers must be approved by the building administrator.

Medical grade PPE is available for interaction with students demonstrating symptoms.

Requirements for 1c. PHYSICAL DISTANCING

- Establish a minimum of 35 square feet per person when determining room capacity. Calculate only with usable classroom space, understanding that desks and room set-up will require **use of all space** in the calculation. This also applies for professional development and staff gatherings. If implementing Learning Outside guidance, establish an outside learning space for learning that maintains minimum 35 square feet per person.
 - Within this design, educators should have their own minimum of 35 square feet and the design of the learning environment must allow for some ability for the educator to move through the room efficiently and carefully without breaking 6 feet of physical distance to the maximum extent feasible.
- Support physical distancing in all daily activities and instruction, maintaining six feet between individuals to the maximum extent possible.
- Minimize time standing in lines and take steps to ensure that six feet of distance between students is maintained, including marking spacing on floor, one-way traffic flow in constrained spaces, etc.
- Schedule modifications to limit the number of students in the building or outside learning space (e.g., rotating groups by days or location, staggered schedules to avoid hallway crowding and gathering).
- Plan for students who will need additional support in learning how to maintain physical distancing requirements. Provide instruction; don't employ punitive discipline.
- Staff must maintain physical distancing during all staff meetings and conferences, or consider remote web-based meetings.

- **Each of the learning spaces in both buildings have been measured and a capacity limit (based on 35 square feet per person limit) established and posted.**
- Students will be cohorted to limit interactions.
- Lunch and recess times will be staggered so that only stable cohorts of students are together. The Old High School Gym and elementary playground may be used for these times, but cohorts will remain separate.

Students will be instructed on how to maintain physical distancing. Additional instruction will be provided to students on proper hand washing and hygiene. Students will also be instructed on the proper way to wear a facial covering. In all circumstances, students shall receive grace when making mistakes regarding distancing requirements. Staff will be trained in redirecting and retraining students when needed.

Requirements for 1d. COHORTING

- Where feasible, establish stable cohorts: groups shall be no larger than can be accommodated by the space available to provide 35 square feet per person, including staff.
 - The smaller the cohort, the less risk of spreading disease. As cohort groups increase in size, the risk of spreading disease increases.
- During the school day, students cannot be part of any single cohort, or part of multiple cohorts that exceed a total of 100 people within the educational week⁴, unless the school is offering Learning Outside, then they must follow guidelines for cohorting in Learning Outside guidance. Schools must plan to limit cohort sizes to allow for efficient contact-tracing and minimal risk for exposure. Cohorts may change week-to-week, but must be stable within the educational week.
- Each school must have a system for daily logs to ensure contact tracing among the cohort (see section 1a of the *Ready Schools, Safe Learners* guidance).
- Minimize interaction between students in different stable cohorts (e.g., access to restrooms, activities, common areas). Provide access to All Gender/Gender Neutral restrooms.
- Cleaning and sanitizing surfaces (e.g., desks, dry erase boards, door handles, etc.) must be maintained between multiple student uses, even in the same cohort.
- Design cohorts such that all students (including those protected under ADA and IDEA) maintain access to general education, grade-level academic content standards⁵, and peers.
- Minimize the number of staff that interact with each cohort to the extent possible, staff who interact with multiple stable cohorts must wash/sanitize their hands between interactions with different stable cohorts.

⁴ The cohort limit is focused on the individual student's experience and their limit of 100 people includes every person they come into contact with in a cohort setting during the day, including staff. While the concept of cohorts and contact tracing still apply, the 100 person limit does not include contacts and cohorts outside the school day, such as transportation or after school program cohorts. There is not a limitation for staff in cohort size while care should be given to design and attention to the additional requirements.

⁵ Academic content standards refer to all of Oregon state academic standards and the Oregon CTE skill sets.

- Elementary staff who interact with multiple cohorts (music, PE, library, paraprofessionals who provide supervision at recesses, etc.) should have schedules altered to reduce the number of cohorts/students they interact within a week. Consider having these staff engage via technology, altering duties so that they are not in close contact with students in multiple cohorts, or adjust schedules to reduce contacts.

The district will provide contact tracing logs to this location.

Disinfection and sanitization of equipment, rooms, restrooms and frequently used touch points will occur in between each cohort of students. Staff will be provided appropriate cleaning supplies so that surfaces and materials can be wiped down in between multiple student uses.

Transportation Cohort

- This is a stable group of students each day.
- Stable groups can be varied by AM/PM routes.
- Updated contact-tracing logs are required for each run of a route.

In-building Cohorts

- Each building is responsible for determining stable cohorts of students based on room/common area capacities.
- Building schedules will be implemented to support physical distancing requirements.
- Grades K-6 are single grade cohorts. Where students interact across grade levels cohort tracking is in place to ensure size limits are maintained.
- To reduce the number of potential interactions Grades 7-12, our schedule has been changed from a 7 period day to a 4 period day. Furthermore, for each quarter, staff were divided into teams to serve grade band cohorts 7-9 and 10-12 in hopes of reducing interactions by staff across the entire school.
- To further reduce the number of potential interactions grades 7-12 MS and HS passing periods were scheduled separately as well as lunch periods.
- Currently, McKenzie has 14 7th graders, 21 8th graders, 14 9th graders, 17 10th graders, 10 11th graders and 10 12th graders. define grade numbers separate MS/HS passing and lunch times.
- Restrooms will be divided as follows to minimize interactions across cohorts. In the primary wing of our elementary building's restrooms will solely be used by grades K, 1, 2 with protected times scheduled for each grade during the day. In the Intermediate wing the restroom nearest the office will be for grades 3, & 4, the restrooms at the end of the hall will be for grades 5 & 6. In the MS/HS building, grades 7-9 will use the restrooms in the middle of the hallway, grades 10, 11, 12 will use the restrooms nearest the office. These will be supervised during breaks and transition times.

- Periodic interval training also keeps the vigilance to protocols ever present when fatigue and changing circumstances might result in reduced adherence to guidance.

- This stable group is maintained as much as possible.
- Contact tracing logs are to be maintained and updated when necessary.

Special Education Cohorts

- This stable group (where appropriate) is maintained as much as possible.
- Contact tracing logs are to be maintained and updated when necessary.

EL Services Cohorts

- This stable group (where appropriate) is maintained as much as possible.
- Contact tracing logs are to be maintained and updated when necessary.

Counseling Cohorts

- Individual counseling of students is preferred and is encouraged; however, students who must participate in group counseling are considered a cohort which will be maintained as much as possible.

Contact tracing logs are to be maintained and updated when necessary.

Requirements for 1f. ENTRY AND SCREENING

- Direct students and staff to stay home if they have COVID-19 symptoms. COVID-19 symptoms are as follows:
 - Primary symptoms of concern: cough, fever (temperature of 100.4°F or higher) or chills, shortness of breath, difficulty breathing, or new loss of taste or smell.
 - Note that muscle pain, headache, sore throat, diarrhea, nausea, vomiting, new nasal congestion, and runny nose are also symptoms often associated with COVID-19. More information about COVID-19 symptoms is available [from CDC](#).
 - In addition to COVID-19 symptoms, students must be excluded from school for signs of other infectious diseases, per existing school policy and protocols. See pages 9-11 of OHA/ODE [Communicable Disease Guidance for Schools](#).

 - Persistent pain or pressure in the chest
 - New confusion or inability to awaken

McKenzie SD will teach and regularly remind staff and students to wash with soap and water for 20 seconds or use an alcohol-based hand sanitizer with 60-95% alcohol. Hand sanitizer use will be required at school and bus entry.

Parent and Staff Education

- Families and staff will be provided with symptom lists and asked to check for symptoms each morning prior to school. Students who are symptomatic must be kept at home.
- Staff who are symptomatic must stay at home.

Student Arrival and Entry

- Individual buildings will assign students a designated entry point to the school building.
- Students will go directly to their first cohort.

Screening Students Upon Entry

- Staff will be assigned to each entry point to visually screen students for symptoms.
- When the screen indicates that a student may be symptomatic, the student is directed to the office. *Follow established protocol from Communicable Disease Management Plan.
- Hand sanitizing stations will be placed by each entrance prior to student entrance
- There are transportation specific screening protocols that must be followed. See section 2i for more information.

Logging for Contact Tracing

Screening Staff:

- Staff are required to report to their building administrator when they may have been exposed to COVID-19.
- Staff are required to report building administrator when they have symptoms related to COVID-19.
- Staff members are not responsible for screening other staff members for symptoms.

All staff, including itinerant staff, substitutes, guest teachers, and essential visitors, will be required to sign in upon arrival through the courtyard entrance. Sign-in logs shall include: email address, date, first and last name, arrival and departure times, building/office, location of activities, and an attestation regarding COVID-19 exposure.

Requirements for 1g. VISITORS/VOLUNTEERS

- Restrict non-essential visitors/volunteers.
 - Examples of essential visitors include: DHS Child Protective Services, Law Enforcement, etc.
 - Examples of non-essential visitors/volunteers include: Parent Teacher Association (PTA), classroom volunteers, etc.

- Visitors/volunteers must wash or sanitize their hands upon entry and exit.

Visitors/Volunteers will be unable to work in schools, or complete other volunteer activities that require in person interaction unless they are deemed as essential personnel. All visitors/volunteers must be approved by the building administrator and will be required to complete training on COVID protocols and this plan. They must also sign a waiver and participate in regular trainings and background checks.

Essential visitors/volunteers must wash or sanitize their hands upon entry and exit.

Essential visitors/volunteers must wear face coverings inside the buildings.

Essential visitors/volunteers will be visually screened for symptoms during sign-in and will not be allowed to enter if symptomatic

Requirements for 1h. FACE COVERINGS, FACE SHIELDS, AND CLEAR PLASTIC BARRIERS

- Employers are required to provide masks, face coverings, or face shields for all staff, contractors, other service providers, visitors and volunteers.
- Face coverings or face shields for all staff, contractors, other service providers, visitors or volunteers informed by [CDC guidelines for Face Coverings](#). Individuals may remove their face coverings while working alone in private offices or when separated by more than 6 feet in outside learning spaces. Face shields are an acceptable alternative only when a person has a medical condition that prevents them from wearing a mask or face covering, when people need to see mouth and tongue motions in order to communicate, or when an individual is speaking to an audience for a short period of time and clear communication is otherwise not possible.
- Face coverings or face shields for all students in grades Kindergarten and up following [CDC guidelines for Face Coverings](#). Face shields are an acceptable alternative only when a student has a medical condition that prevents them from wearing a mask or face covering, or when people need to see the student’s mouth and tongue motions in order to communicate.
- Face coverings should be worn both indoors and outdoors, including during outdoor recess.
- Group mask breaks” or “full classroom mask breaks” are not allowed. If a student removes a face covering, or demonstrates a need to remove the face covering for a short-period of time:
 - Provide space well away from peers while the face covering is removed. In the classroom setting, an example could be a designated chair where a student can sit and take a 15 minute or less “sensory break;”
 - Students must not be left alone or unsupervised;
 - Designated area or chair must be appropriately distanced from other students and of a material that is easily wiped down for disinfection after each use;

- Provide additional instructional supports to effectively wear a face covering;
- Provide students adequate support to re-engage in safely wearing a face covering;
- Students cannot be discriminated against or disciplined for an inability to safely wear a face covering during the school day.
- Face masks for school RNs or other medical personnel when providing direct contact care and monitoring of staff/students displaying symptoms. School nurses shall also wear appropriate Personal Protective Equipment (PPE) for their role.
 - [Additional guidance](#) for nurses and health staff.

Accommodations under ADA or IDEA and providing FAPE while attending to Face Covering Guidance

- If any student requires an accommodation to meet the requirement for face coverings, districts and schools must limit the student's proximity to students and staff to the extent possible to minimize the possibility of exposure. Appropriate accommodations could include:
 - Offering different types of face coverings and face shields that may meet the needs of the student.
 - Spaces away from peers while the face covering is removed; students must not be left alone or unsupervised.
 - Short periods of the educational day that do not include wearing the face covering, while following the other health strategies to reduce the spread of disease.
 - Additional instructional supports to effectively wear a face covering.
- For students with existing medical conditions and a physician's orders to not wear face coverings, or other health related concerns, schools/districts **must not** deny any in-person instruction.
- Schools and districts must comply with the established IEP/504 plan prior to the closure of in-person instruction in March of 2020, or the current plan in effect for the student if appropriately developed after March of 2020.
 - If a student eligible for, or receiving services under a 504/IEP, **cannot** wear a face covering due to the nature of the disability, the school or district must:
 1. Review the 504/IEP to ensure access to instruction in a manner comparable to what was originally established in the student's plan including on-site instruction with accommodations or adjustments.
 2. Not make placement determinations solely on the inability to wear a face covering.
 3. Include updates to accommodations and modifications to support students in plans.
 - For students protected under ADA/IDEA, who abstain from wearing a face covering, or students whose families determine the student will not wear a face covering, the school or district must:
 1. Review the 504/IEP to ensure access to instruction in a manner comparable to what was originally established in the student's plan.
 2. The team must determine that the disability is not prohibiting the student from meeting the requirement.
 - If the team determines that the disability is prohibiting the student from meeting the requirement, follow the requirements for students eligible for, or receiving services under, a 504/IEP who cannot wear a face covering due to the nature of the disability,

- If a student’s 504/IEP plan included supports/goals/instruction for behavior or social emotional learning, the school team must evaluate the student’s plan prior to providing instruction through Comprehensive Distance Learning.
- 3. Hold a 504/IEP meeting to determine equitable access to educational opportunities which may include limited in-person instruction, on-site instruction with accommodations, or Comprehensive Distance Learning.
 - For students not currently served under an IEP or 504, districts must consider whether or not student inability to consistently wear a face covering or face shield as required is due to a disability. Ongoing inability to meet this requirement may be evidence of the need for an evaluation to determine eligibility for support under IDEA or Section 504.
 - If a staff member requires an accommodation for the face covering or face shield requirements, districts and schools shall work to limit the staff member’s proximity to students and staff to the extent possible to minimize the possibility of exposure.

Facial Coverings

Facial coverings are not synonymous with facemasks. Facial coverings are required and will be provided for:

- **All Staff**

Facial coverings are required for all staff/essential visitors/volunteers.

Facial coverings are required for all students in grades Kindergarten and up.

Students who abstain from wearing a face covering, or students whose families determine the student will not wear a face covering during On-Site instruction will be provided access to instruction comprehensive distance learning.

Access to on-site instruction will not be denied for students with medical conditions, doctor’s orders not to wear face coverings, or other health related concerns.

Requirements for 1i. ISOLATION AND QUARANTINE

- Protocols for exclusion and isolation for sick students and staff whether identified at the time of bus pick-up, arrival to school, or at any time during the school day.
- Protocols for screening students, as well as exclusion and isolation protocols for sick students and staff identified at the time of arrival or during the school day. See the [COVID-19 Exclusion Summary Guide](#).
 - Work with school nurses, health care providers, or other staff with expertise to determine necessary modifications to areas where staff/students will be isolated. If two students present COVID-19 symptoms at the same time, they must be isolated at once. If separate rooms are not available, ensure that six feet distance is maintained. Do not

assume they have the same illness. Consider if and where students and staff will be isolated during learning outside. Create a comfortable outdoor area for isolation or follow plan for in building isolation.

- Consider required physical arrangements to reduce risk of disease transmission.
- Plan for the needs of generally well students who need medication or routine treatment, as well as students who may show signs of illness.
- [Additional guidance](#) for nurses and health staff for providing care to students with complex needs.
- Students and staff who report or develop symptoms must be isolated in a designated isolation area in the school or outside learning space, with adequate space and staff supervision and symptom monitoring by a school nurse, other school-based health care provider or school staff until they are able to go home. Anyone providing supervision and symptom monitoring must wear appropriate face covering or face shields.
 - School nurses and health staff in close contact with symptomatic individuals (less than 6 feet) must wear a medical-grade face mask. Other Personal Protective Equipment (PPE) may be needed depending on symptoms and care provided. Consult a nurse or health care professional regarding appropriate use of PPE. Any PPE used during care of a symptomatic individual must be properly removed and disposed of prior to exiting the care space.
 - After removing PPE, hands shall be immediately cleaned with soap and water for at least 20 seconds. If soap and water are not available, hands can be cleaned with an alcohol-based hand sanitizer that contains 60-95% alcohol.
 - If able to do so safely, a symptomatic individual shall wear a face covering.
 - To reduce fear, anxiety, or shame related to isolation, provide a clear explanation of procedures, including use of PPE and handwashing.
- Establish procedures for safely transporting anyone who is sick to their home or to a health care facility.
- Staff and students who are ill must stay home from school and must be sent home if they become ill at school, particularly if they have COVID-19 symptoms. Refer to table in [“Planning for COVID-19 Scenarios in Schools.”](#)
- Involve school nurses, School Based Health Centers, or staff with related experience (Occupational or Physical Therapists) in development of protocols and assessment of symptoms (where staffing exists).
- Record and monitor the students and staff being isolated or sent home for the LPHA review.
- The school must provide a remote learning option for students who are required to be temporarily off-site for isolation and quarantine.

Isolation

- **Bus:** Students shall be screened upon entering the bus for transportation to school. Students exhibiting symptoms or developing symptoms on the bus shall be seated in a designated row and will immediately be taken to the school office upon arrival for

additional screening. Students with symptoms upon screening will be sent to the supervised isolation room until they can be picked up.

- **Upon Arrival:** Students shall be visually screened at their designated entry by staff. Students exhibiting symptoms upon arrival will be taken to the supervised isolation room until they can be picked up.
- **During the Day:** Students and staff exhibiting symptoms shall be sent to the office for screening and placement in the supervised isolation room.
 - Rooms will be marked with signage on doors and access to the room will be clearly prohibited until the student is picked up and the room and contents have been sanitized. Staff interacting directly with the student will wear medical grade PPE.
 - Symptomatic students will remain at school until a designated adult can pick them up.
 - Staff will supervise students who are symptomatic, and will need to maintain at least six feet of distance and wear appropriate face covering or face shields.
 - Logs must be maintained for every student who enters the health room, regardless of whether they are treated or sent home. Logs will include:
 - Name of student
 - Reported Symptoms/reason for health room visit
 - Action taken

Symptomatic Student/Staff Care and Re-Entry

- Staff and students exhibiting symptoms at school site will be reported to LCPH for follow up, we will follow the ODE Scenarios Guidance to determine when they are allowed to return to the school site.

Students and/or staff testing positive for COVID-19 will remain home for at least 10 days and will follow guidance contained in this section ODE/OHA requirements prior to re-entry.

Facilities and School Operations (Section 2 of the RSSL Guidance)

Some activities and areas will have a higher risk for spread (e.g., band, choir, science labs, locker rooms). When engaging in these activities within the school setting, schools will need to consider additional physical distancing or conduct the activities outside (where feasible). Additionally, schools should consider sharing explicit risk statements for instructional and extra-curricular activities requiring additional considerations (see section 5f of the *Ready Schools, Safe Learners* guidance).

Requirements for 2a. ENROLLMENT

- Enroll all students (including foreign exchange students) following the standard Oregon Department of Education guidelines.
- The temporary suspension of the 10-day drop rule does not change the rules for the initial enrollment date for students:
 - The ADM enrollment date for a student is the first day of the student's actual attendance.

- A student with fewer than 10 days of absence at the beginning of the school year may be counted in membership prior to the first day of attendance, but not prior to the first calendar day of the school year.
- If a student does not attend during the first 10 session days of school, the student's ADM enrollment date must reflect the student's actual first day of attendance.
- Students who were anticipated to be enrolled, but who do not attend at any time must not be enrolled and submitted in ADM.
- If a student has stopped attending for 10 or more days, districts must continue to try to engage the student. At a minimum, districts must attempt to contact these students and their families weekly to either encourage attendance or receive confirmation that the student has transferred or has withdrawn from school. This includes students who were scheduled to start the school year, but who have not yet attended.
- When enrolling a student from another school, schools must request documentation from the prior school within 10 days of enrollment per OAR 581-021-0255 to make all parties aware of the transfer. Documentation obtained directly from the family does not relieve the school of this responsibility. After receiving documentation from another school that a student has enrolled, drop that student from your roll.
- Design attendance policies to account for students who do not attend in-person due to student or family health and safety concerns.
- When a student has a pre-excused absence or COVID-19 absence, the school district must reach out to offer support at least weekly until the student has resumed their education.
- When a student is absent beyond 10 days and meets the criteria for continued enrollment due to the temporary suspension of the 10 day drop rule, continue to count them as absent for those days and include those days in your Cumulative ADM reporting.

All students are currently continuing with comprehensive distance learning and attendance on site is both optional and supplementary, to provide academic, social-emotional, and internet access support.

- **Personal Property:** Establish policies for identifying personal property being brought to school (e.g., refillable water bottles, school supplies, headphones/earbuds, cell phones, books, instruments, etc.).

- **Handwashing:** All students and staff will have access to hand washing prior to breakfast and lunch. Frequent opportunities for hand washing will be provided throughout the school day. Hand washing will be supplemented with the use of hand sanitizer.
- **Equipment:** Equipment includes materials such as school supplies (scissors, glue sticks, crayons, markers, etc.), PE and recess equipment, science lab supplies, etc.
 - Sharing of supplies will be restricted whenever possible. Any shared equipment will be cleaned and sanitized between users.
- **Events:** Off-site field trips and events requiring visitors or volunteers have been cancelled.
 - In-school events will be modified to follow cohorting and social-distancing guidance.
 - Building use by outside groups will not be allowed.
 - Athletic events and practices will adhere to OSAA guidelines.

 - Hallways in buildings will include one-way traffic markings to reduce potential contact between cohorts.

 - Restrooms will be assigned based on cohorts. Visual reminders will be used in all restrooms to encourage hygienic practices including:
 - Handwashing techniques
 - Covering coughs/sneezes
 - Social distancing
 - Facial coverings
 - COVID-19 symptoms

Requirements for 2e. ARRIVAL AND DISMISSAL

- Physical distancing, stable cohorts, square footage, and cleaning requirements must be maintained during arrival and dismissal procedures.
- Create schedule(s) and communicate staggered arrival and/or dismissal times.
- Assign students or cohorts to an entrance; assign staff member(s) to conduct visual screenings (see section 1f of the **Ready Schools, Safe Learners** guidance).
- Ensure accurate sign-in/sign-out protocols to help facilitate contact tracing by the LPHA. Sign-in procedures are not a replacement for entrance and screening requirements. Students entering school after arrival times must be screened for the primary symptoms of concern.
 - Eliminate shared pen and paper sign-in/sign-out sheets.
 - Ensure hand sanitizer is available if signing children in or out on an electronic device.
- Ensure alcohol-based hand sanitizer (with 60-95% alcohol) dispensers are easily accessible near all entry doors and other high-traffic areas. Establish and clearly communicate procedures for keeping caregiver drop-off/pick-up as brief as possible.

Entry:

- Students grades K-6 will enter the elementary building through the “Pagoda” building exterior door. Students grades 7-12 will enter the high school building through the south door of the “Old Gym” building they will then be signed in and complete the screening process. Hand-sanitizer stations will be available at entrance to encourage further hygiene.
- Students will transition immediately to their assigned locations.

- Trained staff will be present at the entry point.
- Students will be visually screened upon entry and any student who is symptomatic will be directed to the office.

Exit:

- Students will remain in their assigned cohort and location until the end of their designated time on site. Cohorts will be staggered in order to assure cohorts do not mix during entry and exit. Students will exit directly to their transportation.

Sign-in/Sign-out Procedures

- Visitors who arrive to pick up their child must remain in their vehicle or enter through the main entrance and go directly to the office.
- All sign-in/sign-out tracking will be handled by screener staff to reduce the sharing of pens and paper.
- Any supplies used by more than one person must be disinfected after each use.

Signage will be used to promote physical distancing and hygienic practices.

Requirements for 2f. CLASSROOMS/REPURPOSED LEARNING SPACES

- **Seating:** Rearrange student desks and other seat spaces so that staff and students' physical bodies are six feet apart to the maximum extent possible while also maintaining 35 square feet per person; assign seating so students are in the same seat at all times.
- **Materials:** Avoid sharing of community supplies when possible (e.g., scissors, pencils, etc.). Clean these items frequently. Provide hand sanitizer and tissues for use by students and staff.
- **Handwashing:** Remind students (with signage and regular verbal reminders from staff) of the utmost importance of hand hygiene and respiratory etiquette. Respiratory etiquette means covering coughs and sneezes with an elbow or a tissue. Tissues shall be disposed of in a garbage can, then hands washed or sanitized immediately.
 - Wash hands with soap and water for 20 seconds or use an alcohol-based hand sanitizer with 60-95% alcohol.

Seating:

- All learning spaces and common use areas will have signs posted designating maximum capacity.
- All students will have assigned seats in classrooms to adhere to physical distancing requirements.

- All upholstered furniture and soft seating has been removed from school buildings.
- The courtyard space can be used for outdoor instruction and breaks, physical distancing and cohorts will be maintained outdoors. Face coverings are also to be worn outdoors by all staff and students.

- Classrooms will limit the use of community supplies when possible. If community supplies are used, they must be cleaned frequently and in between each cohort.

Handwashing:

- Keep school playgrounds closed to the general public until park playground equipment and benches reopen in the community (see Oregon Health Authority’s [Specific Guidance for Outdoor Recreation Organizations](#)).
- After using the restroom students must wash hands with soap and water for 20 seconds. Soap must be made available to students and staff. For learning outside if portable bathrooms are used, set up portable hand washing stations and create a regular cleaning schedule.
- Before and after using playground equipment, students must wash hands with soap and water for 20 seconds or use an alcohol-based hand sanitizer with 60-95% alcohol.
- Designate playground and shared equipment solely for the use of one cohort at a time. Outdoor playground structures require normal routine cleaning and do not require disinfection. Shared equipment (balls, jump ropes, etc.) should be cleaned and disinfected at least daily in accordance with [CDC guidance](#).
- Cleaning requirements must be maintained (see section 2j of the *Ready Schools, Safe Learners* guidance).
- Maintain physical distancing requirements, stable cohorts, and square footage requirements.
- Provide signage and restrict access to outdoor equipment (including sports equipment, etc.).
- Design recess activities that allow for physical distancing and maintenance of stable cohorts.
- Clean all outdoor equipment at least daily or between use as much as possible in accordance with [CDC guidance](#).
- Limit the number of employees gathering in shared spaces. Restrict use of shared spaces such as conference rooms, break rooms, and elevators by limiting occupancy or staggering use, maintaining six feet of distance between adults. Establish a minimum of 35 square feet per person when determining room capacity. Calculate only with usable space, understanding that tables and room set-up will require use of all space in the calculation. Note: The largest area of risk is adults eating together in break rooms without face coverings.

- Prohibit self-service buffet-style meals.
- Prohibit sharing of food and drinks among students and/or staff.
- At designated meal or snack times, students may remove their face coverings to eat or drink but must maintain six feet of physical distance from others, and must put face coverings back on after finishing the meal or snack.
- Staff serving meals and students interacting with staff at mealtimes must wear face coverings (see section 1h of the ***Ready Schools, Safe Learners*** guidance). Staff must maintain 6 feet of physical distance to the greatest extent possible. If students are eating in a classroom, staff may supervise from the doorway of the classroom if feasible.
- Students and staff must wash hands with soap and water for 20 seconds or use an alcohol-based hand sanitizer with 60-95% alcohol before meals and shall be encouraged to do so after.
- Appropriate daily cleaning of meal items (e.g., plates, utensils, transport items).
- Cleaning and sanitizing of meal touch-points and meal counting system between stable cohorts.
- Adequate cleaning and disinfection of tables between meal periods.
- Since staff must remove their face coverings during eating and drinking, limit the number of employees gathering in shared spaces. Restrict use of shared spaces such as conference rooms and break rooms by limiting occupancy or staggering use. Consider staggering times for staff breaks, to prevent congregation in shared spaces. Always maintain at least six feet of physical distancing and establish a minimum of 35 square feet per person when determining room capacity. Calculate only with usable classroom space, understanding that desks and room set-up will require use of all space in the calculation. Wear face coverings except when eating or drinking and minimize time in spaces where face coverings are not consistently worn.

- Meals will be provided/available to all students through CDL logistics, those who are onsite will be able to access breakfast or lunch, as appropriate, remaining with their assigned cohort only.
- All staff serving meals are required to wear face coverings while serving meals to students.
- Breakfast and lunch will be grab and go in tents placed on the elementary playground and MS/HS lawn. Students will eat with cohort groups.
- Tables/desks will be cleaned prior to meals being served.
- All students must wash hands prior to meals.
- Students may remove face coverings only while eating, and students and staff should not be moving around the room during this time.
- Students will not share utensils or any other items during meals.

Staff should eat their meals independently and not in shared staff rooms when possible. Break and meal times should be staggered.

Requirements for 2i. TRANSPORTATION

- Include transportation departments (and associated contracted providers, if used) in planning for return to service.
- Buses are cleaned frequently. Conduct targeted cleanings between routes, with a focus on disinfecting frequently touched surfaces of the bus (see section 2j of the **Ready Schools, Safe Learners** guidance).
- Staff must use hand sanitizer (containing between 60-95% alcohol) in between helping each child and when getting on and off the vehicle. Gloves are not recommended; hand sanitizer is strongly preferred. If hand sanitizer is not available, disposable gloves can be used and must be changed to a new pair before helping each child.
 - Develop protocol for loading/unloading that includes visual screening for students exhibiting symptoms and logs for contact-tracing. This must be done at the time of arrival and departure.
 - If a student displays COVID-19 symptoms, provide a face covering (unless they are already wearing one) and keep six feet away from others. Continue transporting the student.
 - The symptomatic student shall be seated in the first row of the bus during transportation, and multiple windows must be opened to allow for fresh air circulation, if feasible.
 - The symptomatic student shall leave the bus first. After all students exit the bus, the seat and surrounding surfaces must be cleaned and disinfected.
 - If arriving at school, notify staff to begin isolation measures.
 - If transporting for dismissal and the student displays an onset of symptoms, notify the school.
- Consult with parents/guardians of students who may require additional support (e.g., students who experience a disability and require specialized transportation as a related service) to appropriately provide service.
- Per federal guidance, drivers must wear properly fitting face coverings at all times. A face shield or goggles may be worn to supplement a properly fitting face covering. Please refer to [the CDC order](#).
- Inform parents/guardians of practical changes to transportation service (i.e., physical distancing at bus stops and while loading/unloading, potential for increased route time due to additional precautions, sanitizing practices, and face coverings).
- Face coverings for all students, applying the guidance in section 1h of the **Ready Schools, Safe Learners** guidance to transportation settings. This prevents eating while on the bus.
- Take all possible actions to maximize ventilation: Dress warmly, keep vents and windows open to the greatest extent possible.

- All bus drivers must wear face coverings while transporting students.
- All bus drivers will be trained by the district in the protocols for loading/unloading students:
 - All students must wear a face covering while being transported on the bus.
 - Students will be visually screened for symptoms when boarding the bus.
 - Students exhibiting symptoms will be required to wear a mask and will be seated in the front seat. The school office will be notified.
 - Upon arrival to school, the student will be escorted to isolation where procedures identified in the Communicable Disease Plan will be followed.
 - If a student develops symptoms while being transported home, the driver will notify the school.
- Bus drivers will keep contact tracing logs and each bus route will be considered a cohort.
- Students must maintain three feet of physical distance while being transported on the bus.
- The driver must maintain a physical distance of six feet from the passengers except during boarding and exiting and while assisting those with mobility needs.
- Buses will be cleaned and wiped down between each route daily.

Staff will consult with families of students who will need additional support on the bus.

Requirements for 2j. CLEANING, DISINFECTION, AND VENTILATION

- Clean, sanitize, and disinfect frequently touched surfaces (e.g. door handles, sink handles, drinking fountains, transport vehicles) and shared objects (e.g., toys, games, art supplies) between uses multiple times per day. Maintain clean and disinfected ([CDC guidance](#)) environments, including classrooms, cafeteria settings and restrooms. Provide time and supplies for the cleaning and disinfecting of high-touch surfaces between multiple student uses, even in the same cohort.
- Outdoor learning spaces must have at least 75% of the square footage of its sides open for airflow.
- Outdoor playground structures require normal routine cleaning and do not require disinfection. Shared equipment should be cleaned and disinfected at least daily in accordance with [CDC guidance](#).
- Apply disinfectants safely and correctly following labeling direction as specified by the manufacturer. Keep these products away from students.
- To reduce the risk of asthma, choose disinfectant products on the EPA List N with asthma-safer ingredients (e.g. hydrogen peroxide, citric acid, or lactic acid) and avoid products that mix these with asthma-causing ingredients like peroxyacetic acid, sodium hypochlorite (bleach), or quaternary ammonium compounds.
- Schools with HVAC systems must evaluate the system to minimize indoor air recirculation (thus maximizing fresh outdoor air) to the extent possible. Schools that do not have mechanical ventilation systems shall, to the extent possible, increase natural ventilation by opening windows and interior doors before students arrive and after students leave, and while students are present. Do not prop open doors that can pose a safety or security risk to students and staff (e.g., exterior doors and fire doors that must remain closed.)

- Schools with HVAC systems should ensure all filters are maintained and replaced as necessary to ensure proper functioning of the system.
- All intake ports that provide outside air to the HVAC system should be cleaned, maintained, and cleared of any debris that may affect the function and performance of the ventilation system.
- Consider running ventilation systems continuously and changing the filters more frequently. Do not use fans if they pose a safety or health risk, such as increasing exposure to pollen/allergies or exacerbating asthma symptoms. Consider using window fans or box fans positioned in open windows to blow fresh outdoor air into the classroom via one window, and indoor air out of the classroom via another window. Fans must not be used in rooms with closed windows and doors, as this does not allow for fresh air to circulate.
- Consider the need for increased ventilation in areas where students with special health care needs receive medication or treatments.
- Facilities must be cleaned and disinfected at least daily to prevent transmission of the virus from surfaces (see [CDC's guidance on disinfecting public spaces](#)).
- Consider modification or enhancement of building ventilation where feasible (see [CDC's guidance on ventilation and filtration](#) and [American Society of Heating, Refrigerating, and Air-Conditioning Engineers' guidance](#)).

- All frequently touched surfaces (e.g., playground equipment, door handles, sink handles, drinking fountains, transport vehicles) and shared objects (e.g., toys, games, art supplies) will be cleaned between uses.
- Playground equipment and classrooms will be disinfected after each cohort using an electrostatic sprayer and other approved devices and disinfectants. Only trained personnel will be able to operate the sprayer.
- Door handles, desks and tables will be cleaned after each cohort group.
- Ventilation systems will be checked and maintained monthly by maintenance staff.
- All facilities will be cleaned and disinfected at least daily to prevent the transmission of the virus from surfaces.

Maintenance has a regular cleaning schedule and will use signage to indicate that an area has been sanitized and is ready for use by a new cohort.

- OAR 581-022-2220 Health Services, requires districts to “maintain a prevention-oriented health services program for all students” including space to isolate sick students and services for students with special health care needs. While OAR 581-022-2220 does not apply to private schools, private schools must provide a space to isolate sick students and provide services for students with special health care needs.

- Licensed, experienced health staff should be included on teams to determine district health service priorities. Collaborate with health professionals such as school nurses; SBHC staff; mental and behavioral health providers; dental providers; physical, occupational, speech, and respiratory therapists; and School Based Health Centers (SBHC).

- Staff will participate in required health services related training to maintain health services practices in the school setting.
- COVID-19 specific infection control practices for staff and students will be communicated.
- Review of 504 and IEP accommodations and health plans will be revised to address vulnerable populations.
- Continuity of existing health management issues will have a plan for sustaining operations alongside COVID-19 specific planning (i.e. medication administration, diabetic care).

Immunization processes will be addressed as per routine timeline, which prioritizes the beginning of the year and new students. Information for immunization clinics will be provided to families.

Requirements for 2l. BOARDING SCHOOLS AND RESIDENTIAL PROGRAMS ONLY

- Provide specific plan details and adjustments in Operational Blueprints that address staff and student safety, which includes how you will approach:
 - Contact tracing
 - The intersection of cohort designs in residential settings (by wing or common restrooms) with cohort designs in the instructional settings. The same cohorting parameter limiting total cohort size to 100 people applies.

 - They have a current and complete RSSL Blueprint and are complying with Sections 1-3 of the **Ready Schools, Safe Learners** guidance and any other applicable sections, including Section 2L of the **Ready Schools, Safe Learners** guidance.
 - The school maintains a fully-closed residential campus (no non-essential visitors allowed), and normal day school operations are only offered remotely through distance learning.
 - There have been no confirmed cases of COVID-19 among school staff or students in the past 14 days.
 - Less than 10% of staff, employees, or contracts (in total) are traveling to or from campus. Staff in this designation will:
 - Limit travel to essential functions.
 - Carefully monitor their own health daily and avoid coming to campus at any potential symptom of COVID-19.
 - Any boarding students newly arriving to campus will either:
 - Complete a quarantine at home for 14 days* prior to traveling to the school, OR
 - Quarantine on campus for 14 days.*
 - A 14-day quarantine is the safest option to prevent the spread of COVID-19 to others. However, in either option above, for boarding students who have not developed any symptoms, schools may consider ending quarantine after 10 days without any testing, or after 7 days with a negative result on a COVID-19 viral test collected within 48 hours before ending quarantine, unless otherwise directed by the local public health authority (LPHA).
 - Student transportation off-campus is limited to medical care.

Requirements for 2m. SCHOOL EMERGENCY PROCEDURES AND DRILLS

- In accordance with [ORS 336.071](#) and [OAR 581-022-2225](#) all schools (including those operating a Comprehensive Distance Learning model) are required to instruct students on emergency procedures. Schools that operate an On-Site or Hybrid model need to instruct and practice drills on emergency procedures so that students and staff can respond to emergencies.
 - At least 30 minutes in each school month must be used to instruct students on the emergency procedures for fires, earthquakes (including tsunami drills in appropriate zones), and safety threats.
 - Fire drills must be conducted monthly.

- Earthquake drills (including tsunami drills and instruction for schools in a tsunami hazard zone) must be conducted two times a year.
- Safety threats including procedures related to lockdown, lockout, shelter in place and evacuation and other appropriate actions to take when there is a threat to safety must be conducted two times a year.
- Drills can and should be carried out as close as possible to the procedures that would be used in an actual emergency. For example, a fire drill must be carried out with the same alerts and same routes as normal. If appropriate and practicable, COVID-19 physical distancing measures can be implemented, but only if they do not compromise the drill.
- When or if physical distancing must be compromised, drills must be completed in less than 15 minutes.
- Drills shall not be practiced unless they can be practiced correctly.
- Train staff on safety drills prior to students arriving on the first day on campus in hybrid or face-to-face engagement.
- If on a hybrid schedule, conduct multiple drills each month to ensure that all cohorts of students have opportunities to participate in drills (i.e., schedule on different cohort days throughout the year).
- Students must wash hands with soap and water for 20 seconds or use an alcohol-based hand sanitizer with 60-95% alcohol after a drill is complete.

Drills will be conducted using most recent guidance for all students and staff.

Safety Drills:

- Evacuation drill
- Lockdown drill
- Earthquake drill

- Staff and students will follow distance requirements during exit of the building
- Re-entry to the building will be through the doors to the classrooms

Safety drills will be carried out as close as possible to the procedures that would be used in an actual emergency. If appropriate and practicable, COVID-19 physical distancing measures can be implemented, but only if they do not compromise the drill. When, or if, physical distancing must be compromised, drills will be completed in less than 15 minutes.

Staff will be trained on safety drills prior to students arriving on the first day of face-to-face engagement.

Students will be instructed to wash their hands with soap and water for 20 seconds, or used a 60%-95% alcohol-based hand sanitizer after the drill is complete.

Requirements for 2n. SUPPORTING STUDENTS WHO ARE DYSREGULATED, ESCALATED, AND/OR EXHIBITING SELF-REGULATORY CHALLENGES

- Utilize the components of Collaborative Problem Solving or a similar framework to continually provide instruction and skill-building/training related to the student's demonstrated lagging skills.
- Take proactive/preventative steps to reduce antecedent events and triggers within the school environment.
- Be proactive in planning for known behavioral escalations (e.g., self-harm, spitting, scratching, biting, eloping, failure to maintain physical distance). Adjust antecedents where possible to minimize student and staff dysregulation. Recognize that there could be new and different antecedents and setting events with the additional requirements and expectations for the 2020-21 school year.
- Establish a proactive plan for daily routines designed to build self-regulation skills; self-regulation skill-building sessions can be short (5-10 minutes), and should take place at times when the student is regulated and/or is not demonstrating challenging behaviors.

Public health and safety requirements will be considered as plans for behavior mitigation strategies are developed. Spaces that are unexpectedly used to de-escalate behaviors will be appropriately cleaned and sanitized after use and before introduction of other stable cohorts in the same space.
