Tax Rate Hearing

A hearing will be held at 6:45 pm, August 10th, 2020, at Raymondville School 135 West HWY B, Raymondville, Missouri, in the library/media room, at which time citizens may be heard on the property tax rates proposed to be set by the Raymondville School District. The tax rates are set to produce the revenues which the budget for the fiscal year beginning July 1, 2020 shows to be required from the property tax. Each tax rate is determined by dividing the amount of revenue needed by the current assessed valuation. The result is the amount of revenue needed by current assessed valuation. The result is multiplied by 100 so the tax rate will be expressed in cents per \$100 valuation.

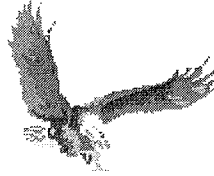

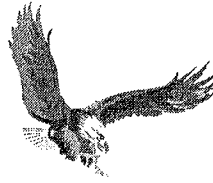
