Teacher Evaluations will proceed for new teachers and any tenured teacher who did not receive an excellent or proficient on their previous evaluation. Professional development trainings that have been offered so far this year include: EZIEP, Aimsweb, CPI, Master Teacher, Putting the Pieces Together, De-Escalation Strategies, and Case Management 101. Time and Out and Restraint is now being reported in SIS.
