Mrs. Hurst- I understand the frustration with distance learning, I appreciate all the teachers, students and parents for hanging in there!


Mr. Snodderly – Nothing to add

Mr. Wallace- Attended a CSBA budge webinar and would like to use the board self-review process as an opportunity to serve students better and make a board action plan for the coming year.


Mrs. Conforti- Has not been an easy school year, looking forward to a new horizon in a new year.
