Part I. GENERAL EXPECTATIONS

Kanawha Elementary agrees to implement the following statutory requirements:

 - How to work with educators

We will do this through monthly Parent Involvement Activities including but not limited to Math and Reading.

9. **Kanawha Elementary** shall provide materials and training to help parents work with their children in the areas of improving student achievement, such as literacy training and using technology (including education about harms of copyright piracy), to foster the achievement of their children by:
