### Insurance

Optional insurance is available for a **premium of \$25.00**. With insurance in place, **the deductible** for any repair or replacement **is \$40.00 per incident**. The total combined benefit for the **2023-24** school year may not exceed the replacement cost of one device. (For example, if a device is lost, coverage is not transferrable to the replacement device.) Purchased coverage will be in place through the end of the **2023-24** school year. Enrollment Period ends 9/8/2023. Insurance covers normal wear and tear and accidental damage. **INSURANCE IS ONLY VALID ONCE PAYMENT IS RECEIVED.**

**Exclusions from coverage billed at full cost are:** Liquid damage, intentional abuse/damage, lost power supplies, lost or stolen devices.
