




WHEREAS the Board of Education may authorize the use of a portion of the beginning fund balance in the budget, stating the amount to be used, the purpose for which the expenditure is needed, and the district's plan to ensure that the use of the beginning fund balance will not lead to an ongoing deficit.

WHEREAS the Board of Education has determined the beginning fund balance in the General Fund is sufficient to allow for the one-time expenditures and the action will not lead to an ongoing deficit.

NOW, THEREFORE, BE IT RESOLVED:

In accordance with C.R.S. 22-44-105(1.5)(a) the Board of Education authorizes the use of a portion of the FY 2019-2020 Beginning Fund Balance for the following funds: General Fund, in the amount of \$4,830,990 to be used for salaries, benefits and purchase services, Capital Reserve Fund in the amount of \$140,000.00 to be used for purchase of a bus and purchase of land.




