

# MERIDIAN CUSD 101

## SPECIFICATIONS LAWN MOWING AND TRIMMING

### 1. Length of Contract:

TWO YEARS: (2021 & 2022) beginning April 1 and continuing through October 31<sup>st</sup> of each contract year.

### 2. Contractor Services:

Meridian CUSD #101 Properties

- A. Lawn(s) must be cut to a height of two (2) inches.
- B. Lawn(s) around or abutting all building, roadways, fences, trees, sidewalks, courtyard, and other improvements shall be mowed and trimmed on a weekly basis or as required by the District Superintendent.
- C. The inside & outside portion of the Water Treatment Facility (Lagoon) shall be mowed monthly with a bush-hog type mower.
- D. All sidewalks shall be cleaned after each mowing.
- E. The CONTRACTOR may be required, as directed by the District Superintendent, to mow and rake grounds at more frequent intervals, if in the opinion of the District Superintendent circumstances indicate the need. F. Provide evidence of insurance with Meridian CUSD #101 **listed**.

### 3. Acceptance/Rejection of Bids

The Board of Education reserves the right to accept or reject any and/or all bids, waive any informalities and technicalities, if any, and award contract, to the bidder that will, in the opinion of the Board of Education, best serve the interests and service needs of the Meridian CUSD 101, Mounds, Illinois.

### 4. Breach of Contract

In the event of an alleged breach of any of the provisions of the Agreement at any time following the date which services commence hereunder, the offended party shall, by written notice, give the offending party, seven (7) days commencing with the mailing of said notice, to correct the alleged breach. In the event said alleged breach is not so remedied to the satisfaction of the offended party during the seven (7) day period, the offended party may, at its discretion, give written notice to the offending party that, at the end of an additional seven (7) day period, the offending party shall consider this agreement breached and that it intends to exercise all its rights under this contract including the right to cancel and be released from all further obligations under this contract.
