The proposed budget includes sufficient funds to provide curriculum and instruction which will enable all students to achieve the Core Curriculum Content Standards, and is in compliance with N.J.S.A. 18A and N.J.A.C. Title 6 and 6A. The proposed enrollment for 2021-2022 is 6,352.

BE IT RESOLVED to acknowledge that the 2021-2022 school year budget as described results in a general fund tax levy of \$83,260,683 and a debt service tax levy of \$8,441,017 for a total tax levy of \$91,701,700; and

BE IT RESOLVED that a withdrawal from the Capital Reserve and Maintenance Reserve of \$1,904,808 for costs related to the loan assessment and expenditures for the health and safety of the students; and

BE IT RESOLVED that the School Interim Business Administrator and the Board Secretary are authorized to advertise said tentative budget in the Home News Tribune as directed by the Department of Education in accordance with the format required by the State Department of Education and according to law: and

BE IT RESOLVED in accordance with the N.J.A.C. 6A:23B-1.2(b), the proposed budget provides for a maximum expenditure amount that may be allotted for travel and expense reimbursement. The 2021-2022 tentative budget includes a maximum travel appropriation of \$104,370 for all staff and board member and business travel at a of rate of \$0.35 per mile; and

BE IT FURTHER RESOLVED that a public hearing will be held in the Staff Development Conference Room of the Administrative Offices at 308 Old Georges Road, Maple Meade School, North Brunswick, NJ 08902 on April 25, 2021 at 7:00 p.m. for a public hearing on the budget for the 2021-2022 school year.
