MINUTES

1. CALL TO ORDER

Chairman Preston called the meeting to order with a reminder that the mission of the Board and Lawrence County Schools is *Every Child College and Career Ready; A Community Involved and Informed.* He led *The Pledge to the United States Flag.*

2. STUDENT/STAFF PRESENTATIONS/RECOGNITIONS

2.A. District Academic Teams

Dr. Fletcher welcomed elementary, middle, and high school academic teams stating that this is one of his favorite recognitions of the year. Coaches introduced their teams and announced the successes of the year that culminates in the Kentucky Governor's Cup Competition. Sisters Carrie Jo and Kate Cecil, representing Lawrence County High School, both placed in state Governor's Cup Competition. Carrie Jo placed 8th in Lawrence Arts and Kate placed 10th in Arts & Humanities. Dr. Fletcher stated, "It's no longer 'you're from Lawrence County and you made it', it's now 'you're from Lawrence County and you're expected to make it". And, these two young ladies have helped to change the expectations of our academic teams because of their hard work ... making it to the Governor's Cup stage at state competition." Dr. Fletcher also thanked retiring high school coaches, Ed Dixon and Scott Osborn, for their hard work and many successes over the past ten years. Certificates of recognition were presented to each team and to Kate and Carrie Jo Cecil.

2.B. LMS: 2018 PLTW Distinguished School

Louisa Middle School has been recognized as a Project Lead the Way (PLTW) Distinguished School for increasing access, engagement, and achievement in PLTW programs. Louisa Middle is one of two middle schools in Kentucky and one of just 110 middle schools across the U.S. to receive this honor for its Gateway program. LMS PLTW teacher Bill Hammond accepted a certificate on behalf of the school and received a certificate in recognition for his leadership in the Science, Technology, Engineering, and Math (STEM) program. Mr. Hammond stated that students have the opportunity to experience three different areas of STEM, Robotics, Engineering, and Medical Detectives. Each of these feed into career tracks at the high school for instance the engineering and biomedical courses. He thanked the board for their support of the PLTW programs in middle and elementary schools throughout the district and the high school.

 - Dr. Fletcher stated that bids were received from three different companies, and a rubric was used to score each bid. Criteria on the bid: time required to complete a cycle of mowing, number of employees, number of mowers (54" or greater), number of comparable contracts, safety equipment, uniforms, background checks. Lawn Express received 35 out of 35 points possible on the rubric; the other two bids were 29/35 and 27/35.

4.F. 2018-2019 TENTATIVE BUDGET WORK SESSION & LOCAL FACILITIES PLANNING DISCUSSION

4.F.1. Overview: Dr. Robbie Fletcher, Superintendent

Funding has decreased in many areas due to cuts in funding at the state level resulting in nearly a \$350,000 cut to the overall budget for next school year. Dr. Fletcher pointed our programs no longer being funded and cuts to existing programs. The state is providing no professional development funds, no funds for instructional materials, and several programs will receive a 6.4% decrease. Preschool funding is dramatically less in addition to higher costs being directed to the district because of the loss of YCC funding and the SIG grant and the rise in utilities.

"As we look at state accountability, we need to adapt to what our students' needs are. We are approaching each day with the goals of proficiency, grade level expectations and higher, and also transition readiness. The budget focuses on achieving these goals while looking for a model for personal learning."

4.F.2. Local Facilities Planning Summary/Information

The board was provided a draft copy of the Lawrence County Schools District Facilities Plan. The plan has been sent to the Kentucky Department of Education for approval. Once it is received back and any recommended changes addressed, the plan will be brought to the board for approval. The earliest for any supporting funds from KDE to replace Louisa West would be 2020, and the most recent amounts awarded to schools for construction has been less than in the past. Dr. Fletcher stated that the board needs to keep the facilities plan in mind as budget discussions occur.

4.F.3. 2018-2019 Tentative Budget Update: Brandi VanHoose, Finance Director

Ms. VanHoose provided and led discussion on the following information:

Tentative Budget

The tentative budget contains the projected revenues and expenditures of all funds for the upcoming fiscal year. State law requires that the local board adopt a Tentative Budget by May 30 of each year.

Revenue

- SEEK (per pupil funding will increase from \$3,981 to \$4,000 the increase has not been reflected in the budget)
- Local (based on 2017-18 revenue)
- Federal (based on the current 2017-18 award amount or grant information we have received at this time)

Expenditures

- Schools allocated according to staffing policy (total number of teachers are based on state
 recommended class size; principal, librarians, counselors, and assistant principal, if applicable,
 are also included in the budget. Secretaries, janitors, and instructional assistants for full day
 kindergarten are included in the base allocation
- Instructional supply allocation is \$100 per student
- Preschool teachers/instructional aides based on 2017-18 and funded by state KERA Preschool grant; one less teacher & one less instructional assistant
- Special education teachers and instructional assistants budgeted are based on population and specific needs
- Five less teachers
- One less instructional assistant
- A 10% increase in water, electric, phone, and natural gas has been budgeted due to an increase in utilities from this current year. This would increase budgeted amount by \$90,000.

"The new Commissioner stated in a webinar that federal funds will not be withheld, but I'd like to see that in writing. Everyone in the region is making cuts." He thanked Mr. Hall for his insight into personnel and Ms. VanHoose for all her work.
