MINUTES

1. CALL TO ORDER

Chairman Preston called the meeting to order with a reminder that the mission of the Board and Lawrence County Schools is *Every Child College and Career Ready; A Community Involved and Informed*. He led *The Pledge to the United States Flag*.

2. APPROVE AGENDA

Approval to amend the agenda to include an additional item, **5.D.3.b.2.** Use of Blaine Elementary gym for adult basketball, passed with a motion by Ms. Garnett Skaggs and a second by Mr. James See by a vote of 5 to 0.

3. STUDENT/STAFF PRESENTATIONS/RECOGNITIONS

3.A. LCHS YCC Engineering Students: BAS Student Internship Project

Youth Career Connect (YCC) students shared their experiences during the BAS Internship Project. They were challenged with a scenario they had to solve by designing and implementing a chain reaction using a limited number of specific items in a limited amount of time. Students said the project challenged them to be creative and that it was a lot of fun. Dr. Fletcher presented certificates of recognition to the students and to YCC Counselor Mary Adams and commented that several of the same students had assisted with a robot station at the recent District Gifted and Talented Technology Day.

3.B. Community Partner Presentation of School Bucks to Lawrence County Schools: Kevin Garrett, Manager and Cheryl Gowan, Food City Human Relations Coordinator

Principals from Blaine, Louisa Middle, and Lawrence County High School accepted checks from Cheryl Gowan and Kevin Garrett of Food City. The amount of the checks varied according to how many patrons had designated their School Bucks purchases to the school during the past school year. It was noted that each year the customer must sign up again in May and designate a school to start accruing the donation. Dr. Fletcher thanked Food City for their support of our students and presented Ms. Gowan and Mr. Garrett a certificate of appreciation on behalf of the Board.

3.C. Lincoln Rose: Rogers Scholar

Lawrence County High School junior Lincoln Rose is a 2017 Rogers Scholar who spent five interesting and challenging days this past summer at Lindsey Wilson College. Using a PowerPoint presentation with photos of events and people he met, Lincoln shared an overview of the Rogers Scholar program and his activities, which included exploring healthcare careers and interacting with nationally recognized business leaders and entrepreneurs. Rogers Scholar focuses on four main things: leadership, technology, entrepreneurship, and community service in addition to providing a scholarship to participants. Lincoln is interested in attending Morehead State University, which provides full tuition and room and board for Rogers Scholars; and his required community service project is a community garden. Dr. Fletcher presented Lincoln a certificate of recognition on behalf of the Board and thanked him for always representing Lawrence County Schools so well.

3.D. District Spelling Bee: LEES Kara Pannell, Champion; BES Devin Thacker, Runner-up

As champion speller in grades four through eight across the district, Kara Pannell from Louisa East Elementary will be representing Lawrence County Schools in the upcoming Kentucky Derby Festival. Community partner, Kentucky Farm Bureau, is funding expenses for the trip in the spring for Kara and her parents. Devin Thacker of Blaine Elementary was runner-up in the spelling bee. Dr. Fletcher praised the students for their accomplishments and presented certificates of recognition to them on behalf of the Board.

3.E. Louisa Middle School Girls' Basketball: 6th/7th/8th Grade Season/Tournament

Head Coach Paul Preece described the girls' basketball program at Louisa Middle and how hard the girls had worked this season and over the past few years. On behalf of the Board, Dr. Fletcher presented team certificates for the following honors and accomplishments: the Seventh Grade Team as Ohio Valley Conference 2017-18 Tournament Champion and Regular Season Champion; the Eighth Grade Team as Ohio Valley Conference 2017-18 Tournament Runner-Up and Regular Season Champion; and the Sixth Grade Team was recognized for a successful regular season.

4. COMMUNICATION

- 4.A. Superintendent's Update
 - 4.A.1. Local Planning Committee holds orientation meeting and public forum on December 5

Dr. Fletcher shared a recent press release on the Local Planning Committee's role and charge in developing the new facilities plan. The committee will review facility information from the architect firm's evaluation of facilities and identify needs across the district. The committee is responsible for putting everything identified into the plan. Once the architect's examination is finished, another meeting will be scheduled. Dr. Fletcher pointed out that the committee includes representatives from every area of the county and every school.

4.A.2. The KASS Board of Directors discuss their legislative agenda during the KASS Conference

Dr. Fletcher, representing Region 10 on the Kentucky Association of School Superintendents (KASS), which includes such neighboring counties as Ashland, Boyd and Carter, described participation in the recent KASS conference. KASS is developing positions on upcoming potential legislative action in January such as the education budget, pension system, home schooling, and school vouchers.

4.A.3. Wednesday, December 20th is the last day for students before Christmas break

Dr. Fletcher provided an update of recent challenges with attendance. Attendance was 91% last Friday, and students and staff are suffering from strep, flu, and stomach illnesses. Thirty-four students were sent home today. School is called off for Tuesday and Wednesday the remaining days in the calendar before Christmas Break.

4.A.4. ACTC offers more dual credit offerings through LCHS than any other high school

Dr. Fletcher expressed appreciation for Ashland Community & Technical College (ACTC) for the opportunities they provide our students; in fact, they offer more dual credit classes at Lawrence County High School than any other regional high school. This not only gets our students prepared for college but they also save money since the college courses are free of charge. More than fifty of our students are taking advantage of the dual credit offerings.

4.A.5. Title IX interest survey has been completed

Students have completed the Title IX interest survey as a first step in creating a boys' soccer team at the high school level. The results will be available in January. Along with the data from the survey, other considerations such as the budget needed to start the soccer program and the equality of girls' sports versus boys' sports will be examined before a decision is made.

4.A.6. Christmas programs/dates provided for each school

Board members had been provided a listing of Christmas programs and their dates, but Dr. Fletcher said that since school has been cancelled for the remainder of the week, these will possibly be re-scheduled after returning to school in January.

4.A.7. Drafts of retirement systems are being developed by multiple groups

Proposals to re-vamp retirement systems that affect all educational staff are being developed and discussed across the state. Dr. Fletcher stated that this will probably be first on the agenda when the state legislature convenes in January.

In addition to providing the Board with the completed Superintendent Gap Assurance Report in their meeting packets, Dr. Fletcher created a table showing delivery target data at the elementary, middle and high school level over the past four years. The Board examined the report and the table of data and discussed causes and improvement strategies. On-going strategies include improving individual classroom instruction, an RtI emphasis, refining the use of formative assessment, and addressing the needs of special education students. Progress has been made, but the state expectation has not been met.

Chief Academic Officer Dr. Cassandra Webb discussed the process of development of the revised plan providing also a summary of the plan and answering questions. Goals were revised according to Kentucky Department of Education guidance and recommendations with data for goals derived from the District Report Card. The major changes, in an effort to align with proposed state accountability, fall under the two Growth goals that are new to the required goals in the plan.
