MINUTES

1. CALL TO ORDER

Chairman Preston called the meeting to order with a reminder that the mission of the Board and Lawrence County Schools is *Every Child College and Career Ready; A Community Involved and Informed* and led *The Pledge to the United States Flag*.

2. APPROVE AGENDA

Approval to amend the agenda to include 5.P.1. Approve to amend and restate the current American Fidelity 403(b) Plan by adopting the new 403(b) Plan Document and to execute the new Administrative Services Agreement and 5.P.2. Approve proposal for Local Planning Committee Facilitator Services with Kentucky School Board Association passed with a motion by Ms. Garnett Skaggs and a second by Mr. James See by a vote of 5 to 0.

3. STUDENT/STAFF PRESENTATIONS/RECOGNITIONS

3.A. Governor's Scholar Program: Carrie Jo Cecil

After a highly competitive, state-wide application process, Lawrence County student Carrie Jo Cecil was selected to participate this past summer in the Governor's Scholar Program, a summer residential program for outstanding high school students in Kentucky who are rising seniors. Carrie Jo stayed on the campus of Morehead State University for five weeks. She shared her experience with the Board stating that the Governor's Scholar Program had not just an academic focus, but one of fostering maturity and responsibility and

interpersonal skills. In response to Dr. Fletcher's request of her to share one experience that stood out above others, Carrie Jo stated that she didn't expect to build such good and lasting friendships. Dr. Fletcher presented a certificate of recognition to her on behalf of the Board, "I know you did a great job representing us and your school well this summer." Carrie Jo responded, "Thank you for preparing me for it."

4. COMMUNICATION

4.A. Superintendent's Update

4.A.1. Solar Eclipse Day's impact to school calendar

Dr. Fletcher explained that although students were not in our schools today due to the partial eclipse experienced in our region of Kentucky, their absence did not add a day to the school calendar. Rather, a Flexible Professional Development Day, scheduled for February 9, was held for staff; and students will attend school on February 9.

4.A.2. Thank you to Pathways for sponsoring Opening Day breakfast

Dr. Fletcher expressed the district's gratitude to Pathways for again sponsoring the Opening Day Breakfast "...at no charge to the district or charge to taxpayers, just a donation." In fact, he stated, they have indicated that sponsoring the event is now a part of their annual budget. "They are a valuable community partner."

4.A.3. Local Planning Committee update

An updated facilities plan is due to the Kentucky Department of Education early in the 2018 calendar year. Dr. Fletcher has shared information with the Board regarding the makeup of the Local Planning Committee. The next step is putting together the committee itself which will occur during the upcoming month.

4.A.4. LCHS One-to-One update

Principal Christy Moore thanked the Board for providing all high school students with a Chromebook. "Student engagement has increased, rigor has increased. In fact, it has changed entirely the way we do things at the high school." During the Flexible Professional Development session at LCHS today called All Things Google, "Teachers shared strategies learning from each other how to incorporate technology into their lessons". Teachers Larisa Skaggs and Autumn Blevins shared the impact of Chromebooks on instruction, their students, and fellow teachers. Students have been enthusiastic about the change, engagement has gone up dramatically, disciplinary issues are down as well as the use of paper in classrooms, and veteran teachers are revisiting their content and figuring out creative ways to teach it using the Chromebooks. Mrs. Moore stated that there had been minimal downsides to the transition to one-to-one technology praising both district technology support and Media Specialist Kim Cecil for excellent management of the process. Mrs. Cecil stated that "...almost all students seem to be cherishing their device." Dr. Fletcher stated that the paper bill is down at the high school and that he has heard and seen positive responses from students and teachers alike. He also noted that even if a student does not have connectivity to the Internet at home, the student can download assignments before going home, work on assignments

at home then as soon as they arrive at school, the Chromebook connects and uploads their work automatically.

4.A.5. Steele Reese Foundation grants for Blaine and LCHS

Funds for the implementation of the Steele Reese Foundation grants were received in the district today. Blaine Elementary received \$30,000 for their library upgrade, and \$20,000 was received for Lawrence County High School for the library and CTE. The second year funding was also received for Louisa West Elementary which upgraded its library last year through a Steele Reese grant.

4.A.6. Instructional data collection process synopsis

Dr. Fletcher stated that Dr. Webb has developed a very nice system to collect data on "how we teach everyday in the classroom and how we do interventions". The first round of data has been collected at the high school and Louisa Middle, and Fallsburg is tomorrow.

4.A.7. Enrollment numbers: Spring 2017 vs. Fall 2017

Currently enrollment is thirty-eight more students than enrolled last year which is also nineteen more students than where we ended last year.

4.A.8. PETLL-ACT work

Principals involved in the Perpetuating Excellence in Teaching and Learning (PETLL-ACT) program are currently implementing instructional coaching in their buildings, and related walkthroughs will begin tomorrow. The schools involved in the instructional leadership improvement grant through the Kentucky Valley Educational Cooperative (KVEC) are Lawrence County High School, Fallsburg Elementary and Louisa East Elementary.

4.A.9. Dual Credit brochure

A brochure promoting dual credit opportunities at the high school has been created in partnership with AEP Credit Counts⁵. Dr. Fletcher pointed out one change, "Instead of AP Calculus being offered, we have Math 175 which is Calc I."

5.F. Update on Drug Awareness Curriculum

Dr. Cassandra Webb, Chief Academic Officer, provided the Board a written report on the first meeting, August 21st, of school and community stakeholders invited to provide input into the development of enhancements to the drug education component of the current health education curriculum in our district. Research has been conducted on the current curriculum, and more specific indicators have been added to the curriculum standards based on the Curriculum Analysis Tool (HECAT) from the CDC. The curriculum was provided to the committee for review. Stakeholders shared current drug awareness/prevention activities already occurring in LC Schools, most in partnership with community partners. The committee determined several components to the initiative including student curriculum, counseling, teacher education, and parent involvement and determined a listing of curriculum program options to explore. Dr. Webb and District Resource Teachers will examine two nationally recognized drug awareness/prevention curriculums recommended by the committee and provide the information electronically for the stakeholders to review in addition to contacting school districts currently implementing the curriculums. Dr. Webb thanked the community members for their support and involvement and said they would be meeting again in September. Dr. Fletcher added, "It was good to see the genuine concern expressed about our students and community. A lot of professionals attended." Chairman Preston

- stated that he appreciated all the work Dr. Webb had done in setting up the meeting. "It was very informative. I realize it involves a lot of work ahead; but it will, I think, be well worth the effort."
