MINUTES

1. CALL TO ORDER

Chairman Preston called the meeting to order with a reminder that the mission of the Board and Lawrence County Schools is *Every Child College and Career Ready; A Community Involved and Informed.* He led *The Pledge to the United States Flag.*

2. APPROVE AGENDA

Approval to amend the agenda to include an additional item, **5.D.2.g.** Contract between Andrea Cyrus and LC Food Service to paint MyPlate information and lunchroom characters on the cafeteria walls of Blaine, Fallsburg, and Louisa East Elementary, passed with a motion by Ms. Maddlene Roberts and a second by Ms. Garnett Skaggs by a vote of 5 to 0.

4. COMMUNICATION

4.A. Superintendent's Update

4.A.1. Progress on the gym floor at Fallsburg

Dr. Fletcher asked Principal Sara Bowen to give an update on the replacement of the gym floor. She has been providing updates on social media. "They will be there tomorrow morning to start laying the actual floor and it should be finished by Thursday." Painting the lines will begin on Monday. The design in the middle will be completed over Fall Break. Mrs. Bowen concluded, "It's going to look awesome!"

4.A.2. Relocation of the Fallsburg flagpole

At the request of local veterans, the flagpole has been relocated to the front of the building. Principal Bowen has arranged for a ceremony on the first day of school for the raising of the first flag on the pole, which will be performed by a local veteran.

4.A.3. Retraction by contractor on Blaine blacktop project

The contractor to whom the Board awarded the bid for the blacktop project retracted his bid, and the remaining bids are from \$20 to \$30,000 more. Dr. Fletcher stated that Blaine project could possibly be completed over Fall Break, or it may need to be re-bid.

4.A.4. Potential cut to Title I/Title II funding

Dr. Fletcher stated that the district had received word at the end of the month that there could possibly be a \$125,000 cut in Title I funding and \$70,000 cut in Title II funding. Purchasing of social studies textbooks, which has been included in the budget, may need to be delayed to cover the shortfall if the cuts are this large. In future years, reduction of staff currently funded through the federal Title programs is likely.

4.A.5. ACT composite at a 5-year high

LCHS is at a 5-year high on ACT composite scores with an average of 18.8. Although still below the state average, Dr. Fletcher stated as the Board reviewed the data, more growth occurred at our high school in several areas as compared to the increase in state composite scores.

4.A.6. PETLL/ACT training at KVEC

Having been selected through a competitive selection process, three principals, Mrs. Moore, Mrs. Bowen, and Mrs. Prince, will be participating in initial Perpetuating Excellence in Teaching and Learning (PETLL) training at KVEC beginning on Thursday and Friday. The focus of the training will be instructional coaching and possibly the use of technology in the classroom.

4.A.7. Micro-credentialing summit at KVEC

Recent legislation will provide more avenues for continuing certification (such as, as opposed to a Master's Degree) for teachers with micro-credentialing being one of them. A possible area for a micro-credential is technology in the classroom. KVEC is taking a lead on this opportunity for teachers and is hosting a summit to explore the potentials of micro-credentialing. Dr. Fletcher will attend the summit on Wednesday at KVEC in Hazard and also Thursday and Friday for PETLL with the principals.

4.A.8. Conference at KASA-Recognition for process improvement

Dr. Fletcher will be attending the KASA Conference next week and will be presenting a session on process improvement work, being an opportunity to highlight the recent work of district administrators and managers in our district. In addition, Lawrence County Schools will be recognized as a North Star District for its process improvement work over the last year and a half, which saved us thousands of dollars.

4.A.9. Latest update for state accountability

Dr. Fletcher highlighted five areas of interest in the potential new state accountability design: a major focus on achievement gaps; a very different growth calculation; a move from College and Career Readiness (CCR) to transition-readiness; a new opportunity and access component; and for overall accountability a change to a star rating.

The Board will review and discuss your progress in open meetings, as documented in board meeting minutes, and your written Summative Evaluation will be discussed and adopted in an open meeting of the Board and reflected in the minutes.

Dr. Fletcher, do you have any questions or comments you wish to share with the Board regarding your evaluation process?"

Dr. Fletcher's commented that the current process is a good one and that he would not recommend any changes to the SPGES process or evaluation instruments.
