

## **BUDGET COMMITTEE**

The district's Budget Committee, comprised of seven elected school board members and seven appointed citizens will meet in May 2021 to review the Superintendent's Proposed Budget for the 2021-2022 school year.

### **2021-2022 Budget Committee Vacancies**

Nyssa School District 26 has three vacancies on the Budget Committee. Individuals wishing to seek appointment to the Committee are invited to complete the Candidate Information Sheet included and send it along with a resume to [atracy@nyssasd.org](mailto:atracy@nyssasd.org), **prior to 5:00 p.m. on Friday, April 2, 2021.**

The Budget Committee consists of seven members appointed by the School Board plus the seven elected School Board members. Budget Committee members are appointed by the School Board to review the District's proposed budget, listen to the Superintendent's Budget Message, listen to public comment, recommend needed changes (within the guidelines of School Board Policy and Oregon State Law), and then approve the budget total and tax rates to be forwarded to the School Board for adoption in June.

Applicants must live in and be registered to vote in the District, and not be an officer, agent, or employee of the District. Positions are non-partisan, unpaid, and are not connected to any specific region within the district. Members with expired terms may request reappointment.

Budget Committee members are typically appointed for three-year terms. Appointments to fill these vacancies will occur during the April 12, 2021 monthly board meeting.

One candidate will be appointed to the Committee to complete the final year of a three year term which expires June 30, 2021.

The second appointment to the Committee will complete the final years of a three year term expiring June 30, 2022.

The third appointment to the Committee will be for a three year term, expiring on June 30, 2024.

Reappointment may be requested just prior to or at the end of each of these terms.

Budget Committee business is conducted in evening public meetings during the month of May. A copy of the adopted Budget Calendar for 2021-2022 is included for review. The Budget Hearing and regular monthly School Board Meeting to adopt the budget, make appropriations and declare the tax levy will be on June 14, 2021.
