RESOLUTION OF THE CULLMAN COUNTY BOARD OF EDUCATION

BE IT RESOLVED by the CULLMAN COUNTY BOARD OF EDUCATION ("the Board") that, after due investigation, discussion and careful consideration, the Board hereby finds and determines that the following statements are true and correct:

(1) the Cullman County Commission has called and will conduct an election in March, 2020 to permit the voters of Cullman County to decide whether a countywide sales and use tax of one cent (.01) to be collected throughout the county, distributed to local boards of education in Cullman County, and used exclusively for public education purposes should be levied under Ala Code §40-12-4 (1975) and then to levy such tax if the voters so approve;

(2) the approval, levy and collection of the countywide sales and use tax is of great financial significance to the Board and beneficial to the overall interests of the Board;

(3) a public purpose is served by the Board promoting awareness of this election among the residents of the District and of the great financial significance to the Board of the approval and levy of the said tax;

(4) the Board's objective in promoting awareness of this election and encouraging a "yes" vote noting the significance of the approval and levy of the said taxes is to promote the general welfare of the Cullman County School District (the "District");

(5) expending Board funds, which are lawfully available and which are not otherwise restricted, and using public property to provide a greater awareness of this election and the significance of the approval and levy of the said tax will confer a direct public benefit to the residents of the District.

BE IT FURTHER RESOLVED that the Board hereby directs and authorizes the Superintendent of Education and the Board's administrative staff, for and on behalf of the Board, to advise the residents of the District of the financial significance of the said tax to the Board and to promote public awareness of the upcoming election and, in connection therewith, to use Board property and expend such funds of the Board as may be lawfully expended for such purposes and as said Superintendent reasonably deems necessary to promote said public awareness of the election and of the significance of the said taxes to the Board's public education mission in the District.

BE IT FURTHER RESOLVED that the Superintendent shall be and hereby is authorized to implement administrative requirements, procedures, and actions deemed necessary or advisable to implement this Resolution and to achieve the purposes thereof.
