Information Sheet

Background Information:

As a result of the 1991-1992 State Aid Act, all Michigan school districts, having more than one school serving a particular grade level are required to establish a School of Choice Program. A committee of administrators, teachers and parents developed the following conditions of the Van Dyke Public Schools – Schools of Choice Program. The plan is reviewed annually and updated as needed.

TERMS AND CONDITIONS

- Resident Schools of Choice is open during "open enrollment times" to residents only. Open enrollment times are determined yearly by the school calendar. Open enrollment will be available for the first Trimester for students in Grades K-5.
- NO LATE APPLICATIONS WILL BE ACCEPTED. Applications for the first Trimester of the 2021-2022 school year will be available March 1, 2021 – August 19, 2021. Applications must be received by 2:00 p.m. August 19, 2021.
- 3. A SINGLE APPLICATION MUST BE FILLED OUT FOR EACH STUDENT (APPLICANT). Only a parent or legal guardian may enroll a student in school.
- 4. Parent / legal guardian must provide a copy of the student's most recent report card, progress report or transcript which shows grades, conduct and attendance, when returning this application.
 NO APPLICATION WILL BE ACCEPTED WITHOUT THE ABOVE INFORMATION.
- 5. The parent(s) / legal guardian must guarantee positive student attendance and behavior. Van Dyke Public Schools reserves the right to transfer or disenroll any student, causing concern in any area of the district's <u>Student Code of Conduct</u> will be subject to outlined discipline up to and including expulsion. Students who were suspended from their home school during the preceding two (2) school years and / or were expelled at any time from any school, will not be accepted.
- Students granted a Resident Schools of Choice request may remain in the School of Choice through grade five, unless the student's parents / legal guardian move out of Macomb County.
- 7. Vacancies for the Resident School of Choice Program will be those seats not occupied by a "neighborhood school" student and within the district's class size limits. Up to 1% of the seats available for students in a given school will be available for enrollment of students under our district's School of Choice Program.
- 8. Any student who is currently enrolled cannot be displaced under this plan.
- 9. If the number of pupil applicants exceeds the number of vacancies allowed for a particular school, students will be selected to attend the school of choice through a random drawing (lottery).
- Applicants may apply to one school only, under the Schools of Choice Program. Students must remain in their "School of Choice" school for the entire school year.
- 11. Parents are responsible for transportation to and from the "school of choice".
- 12. Students will remain enrolled in their home school until such time as they are notified of the decision on their Resident Schools of Choice application(s).
- 13. Schools of Choice applications are available from the Office for Curriculum & Instruction at the Van Dyke Public Schools Administrative Service Center
- 14. Applications for the Resident Schools of Choice program may be mailed to the Van Dyke Public Schools Administrative Service Center Office for Curriculum & Instruction, but must be postmarked no later than August 19, 2021.
