#### MINUTES

#### 1. CALL TO ORDER

Chairman Preston called the meeting to order with a reminder that the mission of the Board and Lawrence County Schools is *Every Child College and Career Ready; A Community Involved and Informed*, and he then led *The Pledge to the United States Flag*.

#### 2. APPROVE AGENDA

Approval to amend the agenda to include Use of Facilities 5.D.3.b.5. Blaine Elementary School by Blaine High School Alumni Committee for the annual reunion passed with a motion by Ms. Maddlene Roberts and a second by Ms. Garnett Skaggs by a vote of 5 to 0.

#### 3. STUDENT/STAFF PRESENTATIONS/RECOGNITIONS

Dr. Fletcher led a moment of silence in honor and respect for former Lawrence County High School teacher, Patsy Cash, and former bus driver, Hughie Roberts, the husband of board member Maddlene Roberts, for their service to our students and the community.

#### 3.A. Teachers With Highest MAP Gains: Fall 2015 to Spring 2016

Dr. Fletcher congratulated and presented certificates of recognition for the highest growth for the entire 2015-16 school year from fall to spring. He noted that in testing across the state, growth doesn't often get recognized. "It's important where you get students and where you take them. We really appreciate the hard work you do." On behalf of the Board, Chairman Preston extended congratulations and appreciation for the teachers' success and hard work.

#### 3.B. Fallsburg Elementary Principal Sara Bowen

Dr. Fletcher introduced Fallsburg's new principal, Sara Bowen, former teacher at Louisa West Elementary School. He noted that Principal Debbie Delong had highly recommended her for her new position.

#### 4. COMMUNICATION

#### 4.A. Superintendent's Update

#### 4.A.1. Steele-Reese Foundation grant awarded to LWES library

Congratulations were extended to both Principal Delong and Librarian Angela Conley, who applied for the grant which is for \$30,000 over two years. Ms. Delong stated that they are very excited to get new technology and new books. Dr. Fletcher stated that both Chris Jobe and Jim See had brought the grant to our attention.

#### 4.A.2. Surplus balance in the Unemployment Fund for 2015

What was paid out in claims was less than the amount contributed to the Unemployment Fund resulting is a payback to the district of \$937.

#### 4.A.3. Latest enrollment numbers for each school vs. the end of last year

Having ended the school year with 2,464 students, current enrollment is 2,482. In addition, the increase in ADA last year results in additional dollars for the district. Dr. Fletcher thanked principals, assistant principals, attendance clerks, and Mr. Hall for a successful attendance year.

Appointments were finalized this past month, and Dr. Fletcher has been appointed to the Kentucky Association of School Administrators as the Region 10 representative replacing the retiring Ashland superintendent.

#### 4.A.7. Property acquisition update

The family has accepted the assessed value quote of \$62,500, and the next step is KDE approval which will take place hopefully in the next few weeks.

The board has invested over \$500,000 in math and reading/English/language arts textbooks in the past two years. The professional development received at the beginning of schools was well received and a good investment.

Chief Information Officer Tommy Burns reviewed the documents provided to the Board prior to the meeting (Data Security and Breach Notification Best Practice Guide, Policy 01.61 Records Management, and Procedure 01.61 AP.11 Notice of Security Breach & Investigation Procedures). He also described the district's personal information security procedures and answered questions noting that our procedures are based on KDE's Best Practice Guide and are recommended by the Kentucky School Board Association.

**5.I.** Approval of permission to apply for the Preschool Partnership Grant by Rhonda Colvin, Director of Special Education and Preschool passed with a motion by Ms. Maddlene Roberts and a second by Ms. Garnett Skaggs by a vote of 5 to 0.

Ms. Colvin noted that although the grant seeks to involve another community early childhood provider in the area as a grant partner, none were interested in partnering with Lawrence County Schools for the grant. An implementation grant amount of \$150,000 is being sought.

- **5.J.** Approval to declare as surplus property unused textbooks at Lawrence County High School and Fallsburg Elementary School passed with a motion by Ms. Garnett Skaggs and a second by Ms. Barbara Robinson by a vote of 5 to 0.
- **5.K.** Approval of the *Unaudited Annual Financial Report for Fiscal Year 2016* passed with a motion by Mr. James See and a second by Ms. Garnett Skaggs by a vote of 5 to 0.

Ms. Humphrey reviewed the financial audit report with the Board noting that the auditor is currently in the district and will be writing his report in September; however, due to a delay in information from KTRS, he will not be reporting to the Board until October. She noted that although the Board has been able to approve several special purchases such as the textbooks, overall spending has been conservative. "We have focused dollars on school improvement and have also saved." She further stated that in 2017 technology needs, both current and future, need to be considered as does the purchase of buses this fall. Chairman Preston commended Ms. Humphrey for her efforts over the past years.

The controls and devices in question are removable and can be used in other buildings once Louisa West is replaced by a new building in the future. Discussion included looking at other areas of need and setting priorities before committing to the energy upgrades. Dr. Fletcher noted that purchase of StemScopes kits needs to be considered to accompany the StemScopes program purchased for teachers to help with implementing the new science standards.
