#### **MINUTES**

#### 1. CALL TO ORDER

Chairman Preston called the hearing to order with a reminder that the mission of the Board and Lawrence County Schools is *Every Child College and Career Ready; A Community Involved and Informed*.

#### 2. STUDENT LEARNING AND SUPPORT SERVICES

2.A. Communication: School & Community Days

Dr. Fletcher shared the dates of the Fall School & Community Days held at each school and a description of the activities and events that occur. Two visits have already occurred, Louisa West Elementary on October 7 and Louisa East, today, October 8. Upcoming are Lawrence County High School on October 12, Louisa Middle on October 14, Fallsburg Elementary on October 26 and Blaine Elementary on October 27. Superintendent Fletcher and the District Administrative Team visit classrooms to observe, participate, and talk with students and staff. Immediately following the school day, there is a meeting with staff to share information and answer questions. The Day ends with a Town Hall event during which parents and the community can ask questions and share thoughts or ideas. Dr. Fletcher discussed several needs that were identified last year during School & Community Days that have subsequently been met. Another round of School & Community Days will be held in the spring. Dr. Fletcher concluded that this is "an opportunity to let parents know we care".

### 2.C. Public Comment

- 2.D. Approval to set the Real Estate/Personal Property Tax Rates, changing our status to include aircraft and watercraft, at 52 cents and the Motor Vehicle Tax at 30 cents passed with a motion by Ms. Garnett Skaggs and a second by Ms. Maddlene Roberts by a vote of 5 to 0. The general areas to which revenue of \$141,943 above 2015 revenue is to be allocated are as follows: Cost of collections; \$4,258; technology \$68,842.50; transportation \$68,842.50.
- **2.E.** Approval of the 2015-2016 Working Budget passed with a motion by Ms. Barbara Robinson and a second by Mr. James See by a vote of 5 to 0. Finance Director Edris Humphrey provided an overview.

The 2015-2016 Working Budget for Lawrence County Schools totals \$27,845,710. The working budget report reflects the prior two years of receipts and expenditures and current year budget appropriation for projected receipts and expenditures. All funds are reflected in the working budget. Revenue information includes: 18% of the revenue reflected in the budget is from local revenue; 37% is from SEEK. 9% is from the carry forward/beginning balance, food service indirect costs, and Medicaid reimbursements. 11% is from State On-Behalf Payments; 13% from state and federal grants; and 4% is restricted in Capital Outlay, Building Fund, and Construction Fund. The remaining 8% is Food Service. Expenditures are as follows: 55% is budgeted on Instruction, Student Support Services and Instructional Staff Support; 2% for District Administrative Support; 4% for School Administrative Support; 1% for Business Support; 10% for Plant Operations and Maintenance; 7% for Student Transportation; 4% for Debt Service; 8% for Food Service operation; and 7% is reserved for the Contingency. Overall, 70% is budgeted for Personnel (74% in Fund 1; 88% of Fund 2; and 41% Fund 51).

**2.F.** Approval to lease three buses passed with a motion by Mr. James See and a second by Ms. Maddlene Roberts by a vote of 5 to 0. *Total cost:* \$326,907
