MINUTES

1. CALL TO ORDER

Chairman Preston called the meeting to order with a reminder that the mission of the Board and Lawrence County Schools is *Every Child College and Career Ready; A Community Involved and Informed.* He then led *The Pledge to the United States Flag.*

2. APPROVE AGENDA

Approval to amend the agenda to include excusing Mr. See's absence due to family illness and adding several items (**5.D.2.** Contract: Louisa Middle with New Tech Systems, Inc. for sound system for gym and auditorium; **5.D.3.a.3.** Fundraiser for Louisa East Elementary; **5.D.3.c.** Out of State Training: Student Self-Regulation Seminar in Charleston, WV on December 4th; and **4.A.9.** Accreditation of University of Kentucky College of Education) passed with a motion by Ms. Barbara Robinson and a second by Ms. Maddlene Roberts by a vote of 4 to 0 with Mr. See absent.

3. STUDENT/STAFF PRESENTATIONS/RECOGNITIONS

3.A. LCHS: Conner May, 2015 Rogers Scholar

Conner May was honored with a certificate for graduating this past summer from the Rogers Scholar leadership program held on the campus of Lindsey Wilson College, along with sixty-three other high school students across Kentucky. Conner shared details of his experience stating that it was a great learning experience in the areas of business and entrepreneurship.

3.B. Junior Lego League

Two teams of students, the Bulldog Builders and Team Lego-Atronics, from the first Lego League in Lawrence County displayed and explained their projects from a recent junior division competition in West Virginia. The projects consisted of both a Lego model and a Show Me Poster, which outlined the research, steps, and process the students took in designing their model. Marsha Slone, Lawrence County Lego League Coordinator and coach of the senior league, discussed the benefits of the program and its correlation to STEM and her plans to recruit more Lawrence County teams and to expand Lego Leagues in Kentucky. Dr. Fletcher presented certificates to the students and coaches on behalf of the board.

3.C. National Board Certification: Melissa Blackburn, LCHS CTE Agriculture Teacher

Dr. Fletcher presented Ms. Blackburn a certificate of recognition for her success in seeking and obtaining National Board Certification. Ms. Blackburn stated that some of the valuable things she experienced in the certification process was using reflection to inform how to teach, what to teach, and the importance of it to students. Dr. Fletcher stated, "We have three National Board Certified teachers in the district, and we welcome you to those ranks."

4. COMMUNICATION

4.A. Superintendent's Update

4.A.1. KSBA Winter Symposium: December 4-5

Board members will be attending the Kentucky School Board Association Winter Symposium on December 4th and 5th for training such as required finance training. Plans and the training registration process were discussed.

4.A.2. KASS Conference: December 6-8

Dr. Fletcher will be attending the statewide Kentucky Association of School Superintendents immediately following the KSBA Winter Symposium. This is an opportunity for leadership training offered through various seminars.

4.A.3. SIG 2.0 update

Dr. Fletcher noted that even with the high school exiting Persistently Low Achieving status and being designated a Distinguished School, the district was offered the opportunity to submit a grant designed to sustain the progress that has been made over the last several years. According to KDE, the district should be notified of the amount of the School Improvement Grant award this week.

4.A.4. Comprehensive District Improvement Planning Process: Dec. 8 @ 4:30 p.m.

Dr. Fletcher noted that the focus of the District Improvement Plan is how to move us to a Distinguished District and to continue providing more opportunities to our students to succeed on a daily basis. Two board members are part of the committee as well as high school students for the first time last year in addition to teachers and other stakeholders across the district and community. The upcoming meeting agenda will provide opportunities to discuss specific strategies such as a Dual Credit Academy and STEM activities in school.

4.A.5. Payroll discussions/surveys

Within the next month, as requested previously by the board, the district will be seeking input of all employees regarding the design of the payroll schedule. The focus of the survey will be on whether to continue on a 26-checks per year pay schedule or move to 24 checks with payroll occurring on the 15th and 30th of each month. Dr. Fletcher stated that efforts are being made to address issues that periodically occur with the beginning or ending of the school year.

4.A.6. Cleanliness surveys by our maintenance department

Dr. Fletcher complemented the maintenance department and Mr. Gary Colvin for efforts to provide clean environments in which students can learn and for working to identify areas of improvement. Cleanliness surveys, with thanks to Mr. Tommy Burns from technology, are being used to seek input from principals, teachers and staff as a part of the district improvement process.

4.A.7. Evaluation of bus routes

Dr. Fletcher thanked Mr. Rick Blackburn for his efforts in examining individual bus routes throughout the county to identify ways that students can be picked up at the latest time possible shortening their time on the bus. He noted that one student is being picked up at 6:02 a.m.

4.A.8. Technology vision for each school

Dr. Fletcher recognized Mr. Burns for his leadership in helping schools develop a technology vision for schools and students after the board designated \$50,000 for the technology budget. Mr. Burns is asking: What does technology look like currently in your building? What would you want each of your classrooms to look like in ten years? What do you want for students regarding technology? Dr. Fletcher noted, however, that the district is behind in replacing a lot of our machines and that that will have to be the focus for the next few years.

4.A.9. Accreditation of University of Kentucky College of Education (added to agenda)

Dr. Fletcher was invited and participated, along with five other superintendents across the state, in the accreditation process for the University of Kentucky College of Education yesterday in Lexington. Dr. Fletcher stated that it was an honor to represent Eastern Kentucky and Lawrence County in the process and to also network with other superintendents about what is going on in other school systems. Other superintendents invited to participate were from Boone County, Kenton County, Marshall County, Walton-Verona, and Henry County.

4.B. Presentation of School Bucks for Lawrence County Schools: Cheryl Gowan, Food City Human Relations Coordinator & Kevin Garrett, Manager

Almost \$4,000 in Food Bucks checks for the 2014-15 school year were presented to schools on behalf of the Food City Food Bucks program at Food City of Louisa. Lawrence County High School received a check for \$2,802.09. Ms. Gowan praised then Family Resource Director Deana West for the success she had in garnering parents and the community to sign-up for the program. "This is free money for the school and at no cost to the consumer who shops at Food City", stated Ms. Gowan.

Mr. Garrett, giving apologies for the regional manager's absence, explained that of the twelve Food City stores in Eastern Kentucky and in competition with larger towns such as Pikeville, LCHS had earned the greatest monetary award. Principals were present to receive the checks earning \$1,000 free points toward the current year's Food Bucks. Parents and community members must sign up annually for the program since participation does not carry over from year to year. Dr. Fletcher thanked Ms. Gowan and Mr. Garrett stating that Food City is a wonderful community partner for our school system and for our students.

4.C. Broken Arrow Archery Club Presentation

Representatives from the Broken Arrow Archery Club provided information on the benefits and opportunities to students from participation in archery programs in schools and asked the board to consider either providing an indoor site for after-school archery practice or to develop archery as a school-related activity including a partnership with Scholastic 3D Archery. The district will check into similar programs in other schools.

Fund 1 cash balance for the month of October was \$1,845,713. The ending balance of all funds for October is \$1,975,197.

- 5.E. District Budget Needs Assessment Summary: Superintendent Fletcher & Finance Director Edris Humphrey
 - Dr. Fletcher explained that the budget planning process includes a very comprehensive needs assessment from all schools and departments in the school system. Providing examples of the funding requests, he stated that in regards to funding decisions, "We must consider what will make the biggest difference with students." Ms. Humphrey reviewed the process she used in collecting the needs on the summary spreadsheet presented to the board and summarized the steps and timeline for developing next year's budget. She also stated that the needs list will continue to be used throughout the yearly budget process and will have the costs added at the draft budget stage. At Ms. Robinson's request, the gym floor was added to the needs list under Fallsburg, and Chairman Preston asked that an alternative classroom be added to Louisa Middle School's list. Dr. Fletcher noted that different funding sources are being looked at to keep the district in the black and concluded referencing some "dream" items that are on the needs assessment list such as a Dual Credit Academy for LCHS.

 - 6.D.1. Collaborative Leadership -- The community effort to attract Sullivan University

Dr. Fletcher provided an update on his recent actions regarding one of the standards of SPGES, Collaborative Leadership. One example is that he continues to work with community leaders, such as the County Judge Osborne and Catrina Vargo, Economic Director, and to step outside the county line in working with Sullivan University to bring them to Lawrence County. The latest is that Sullivan will be coming in some capacity, at least offering distance learning. Another good example of the collaborative leadership standard is the trip Dr. Fletcher made yesterday to the UK College of Education to participate in their accreditation process. Dr. Fletcher also stated that he will be asking the Board to give him a mid-year review in January, as they did last year.
