Stuart Public Schools has been allocated \$938,616.01 in ARP ESSER III funds to help us Prevent, Prepare for, or act in Response to COVID 19. After meeting with the Consultation Committee Made up of Stakeholders of the District (Students, Parents, Faculty/Staff, Tribal Liaisons, and Business leaders) the District developed the following plan for the Use of those ARP funds.

1. The extent to which and how the funds will be used to implement prevention and mitigation strategies that are, to the greatest extent practicable, consistent with the most recent CDC guidance on reopening schools, in order to continuously and safely open and operate schools for in order to continuously and safely open and operate schools for in-person learning;

The ARP Consultation Committee of Stuart Public School has discussed various ways to help make our school safe and healthy for students, teachers, and staff. Keeping this in mind, and using the CDC guidelines to direct decisions, Stuart Public Schools have agreed to the following uses of ARP ESSER III funds in order to Prepare, Prevent, or Respond to Covid 19 and its impact:

- A. FY22 FY24 Construction Add-on of 2800 sq. ft. with areas to enable lower elementary a place to have recess during inclement weather, Lower elementary to have PE when the original PE area is taken by cafeteria tables for social distancing, a computer lab/seminar center to be able to social distance during Mandated State Tests or seminars, and two handicap accessible restrooms to allow for social distancing during breaks. Includes Architect and Construction fees.
- B. Security Cameras to aid in Contact Tracing for close contact and exposure.
- C. Cleaning Supplies for building and grounds and for personal hygiene to help prevent the spread of COVID 19
- D. Nurse Supplies in response to COVID-19

2. How the LEA will use the funds it reserved under section 2001(e)(1) of the ARP Act [20% of ESSER ARP Act formula funds] to address the academic impact of lost instructional time through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year;

20% of Stuart Public School's total ARP ESSER III funds (\$938,616.01) will be \$187,723.20. These funds will be used to help eliminate individual student and grade level learning gaps in Science due to Covid 19, and then to address such loss through research-based interventions and STEM programs. Therefore, the following are recommendations from the Consultation Committee:

- A. With the significant number of students in High School having below level performance on the Science portion of the ACT (part of state mandated test for 11 grade science), a Science teacher will be hired for 3 years to help bridge the gap and in declining scores. (begin FY21)
- B. (FY 23 FY 24) STEM equipment and STEM supplies for Science 20% set aside for Learning Loss.
- C. (FY 22 FY24) Ed Puzzle and IXL will be used to enhance On-line Curriculum for use when or if forced to be on distant learning, and to supplement learning for those behind in not only Science, but any other area.
- D. For FY 24, the Alpha Plus program which includes Professional Development to help increase student achievement, has been added.
- E. FY 23 Amplified IT added to Google workspace to allow for better virtual instruction

In order to maintain operations and continuity of the district in either direct preparation for, to prevent, or in response to Covid 19; or because of loss of revenue due in large part to the same, the District will utilize the various approved funding uses in the following manner:

FY 23 – FY24 In order to support federal programs by providing consultation and support for applications, Stuart Schools will contract with Barlow and Associates.

In FY 24, Contract with Aptegy, for "Rooms" and "Thrillshare" for School District and teacher 2 way communication with parents and for professional development to support those programs.

100% of funds are dedicated to Items 1, 2, and 4. If any funds remain as items in #2 or #4 come in under expected costs, we would meet and discuss transferring those funds to item #3 to be able to reduce any disproportionate affects on students or staff due to the COVID 19 Pandemic.
