
Proposed Budget Presents Spending Plan of \$44,366,439.00

- An increase in expenditures of 2.92% over last year
- Tax Levy increase of 0.00% (Allowable tax cap for simple majority vote is 1.48%)
- The projected annual increase in school tax for a home assessed at \$85,000 would be \$0.00 (Note that, while the proposed tax levy is 0.00%, actual amounts are subject to change due to fluctuations in assessed valuations and New York State equalization rates, both of which will be finalized during the summer.)

District Continues to Earn Rebates for Homeowners

Because the District is containing the tax levy below the tax cap, District homeowners are once again eligible for a State property tax rebate, payable in autumn 2016, mailed directly to homeowners from NYS.



Understanding the Tax Levy

- Residents vote on the overall proposed budget; they do not vote specifically on the tax levy.
- The tax levy is the money needed to balance the budget after expenditures, revenue, and appropriated fund balance have been finalized.
- The NYS Tax Cap Law for school districts uses a formula to re-calculate every year each district's allowable levy for a simple majority vote. Districts can go over that amount, but need super-majority approval to do so.
- Prior to the Tax Cap Law, our District's ten-year average of tax levy increases was 1.66%.
- Since the Tax Cap Law was enacted in the 2012-13 fiscal year, Batavia City School's five year average allowable tax cap has been \$572,470 or 3.15%. The actual tax levy average increase over this same five year period has been \$143,173 or 0.80%. Three of the five years there has been no increase in tax levy.
- Over the last 10 years, the tax levy has average an increase of \$118,917 or 0.68%
- For 2016-17, our District's allowable tax cap (for simple majority vote) is 1.48%; the Budget Proposal calls for a flat tax levy (0.00%).

District Continues to Pursue Alternative Funding

- Rental of space at Robert Morris
- Use of Reserves: The Proposed Budget calls for using \$2.085 million from Unemployment Insurance Reserve, surplus Fund Balance, Employee Benefits Accrued Liability Reserve, Repair Reserve, and NYS Employees Retirement Reserve.
- The District competes annually for State and federal grants and anticipates \$2.5 million for 2016-17. This money contributes to targeted programs to improve learning for disadvantaged students, supplement professional development, and provide UPK which helps 75% of our incoming kindergarteners get a jump on school success.
- The newly formed Batavia City School District Foundation enables donors to recieve a tax deduction for contributions while creating an alternative funding source for District initiatives.
