#### AMENDED OFFICIAL MINUTES

June 15, 2015 Regular Meeting

#### **101. CALL TO ORDER**

Chairman Preston called the meeting to order with a reminder that the mission of the Board and Lawrence County Schools is *Every Child College and Career Ready; A Community Involved and Informed.* Mr. Preston led *The Pledge to the United States Flag.*

#### **104. COMMUNICATION**

#### 104.A. Superintendent's Update

104.A.1. Community partners donate for soccer scoreboard: Coca Cola Bottling Company, Three Rivers Medical Center, Wheeler & Clevenger Oil Company and Lycom Communications Dr. Fletcher recognized and thanked community partners: Coca Cola Bottling Company, Three Rivers Medical Center, Wheeler & Clevenger Oil Company and Lycom Communications. "Their donations have made it possible to place a brand new scoreboard on our soccer field. We are very grateful for their support."

# 104.A.2. TELL Survey

TELL (Teaching, Empowering, Leading and Learning) Survey Data has been released. Dr. Fletcher will be discussing the results with the board later this week during the superintendent evaluation.

### 104.A.3. Sullivan University

Dr. Fletcher announced that positive feedback has been received from Sullivan University officials on setting up a satellite center in the old courthouse annex. After seeking a similar agreement with regional universities that failed, Dr. Fletcher is optimistic about a partnership between Sullivan and local government entities. Sullivan's president toured facilities and met with local partners at the end of May, and their nursing division will conduct a visit soon. Tentative plans are that post-secondary opportunities, especially in the area of nursing, will be made available to the community and our high school graduates.

# 104.A.4. Standards-Based Grading in Math

An instructional change for next year will be standards-based grading in math for all students, K through 12. Dr. Fletcher recently led middle grade math teachers in a professional development on standards-based grading; and common understandings were developed including setting grading as 75% standards mastery and 25% homework.

# 104.A.5. LCHS CCR

Based on calculations today, the high school's College and Career Readiness index is 81.1, an 8point gain over last year. Principal Moore stated that additionally they await results of nineteen students in the nursing career track (CNA). Successful completion of their program will produce either bonus points or status as first time completers resulting in potentially a CCR index of 90 or higher. Dr. Fletcher noted that this would be "well above the state average. With the data we have so far, the high school is on track to come out of PLA status."

### 104.A.6. EOY School Celebrations

In addition to attending many end-of-year events at schools across the district, Dr. Fletcher added to the celebration of high school graduation in a unique way. One each hour of graduation day, he published a special message or question about the successes of the exiting senior class. These include: the academic team was back-to-back district champions; girls' soccer won the region for the 3<sup>rd</sup> time in a row and the district for the 4<sup>th</sup> time in a row; girls' tennis won the region for the 5<sup>th</sup> time in a row and the district for the 4<sup>th</sup> time in a row; boys' tennis won the region and district for the 7<sup>th</sup> time in a row; baseball won the region as well as the district; Bass Club participants have qualified for national tournament competition two years in a row; boys' basketball was regional runner-up and girls' basketball was district runner-up. In addition, the CCR index will be one of the highest in the state. Dr. Fletcher stated he was proud of the Lawrence County staff and applaud them for building these winning programs.

### 104.A.7. Payroll Calendar

Dr. Fletcher expressed concern over the financial hardship caused by the 2015-16 Payroll Calendar. Staff receive twenty-six checks per year; but the way the checks rotate, the paydays keep moving

earlier and earlier each year. In checking with surrounding districts, they have experienced similar situations. The first payroll for the upcoming school year for all 10-month employees (teachers, bus drivers, cooks, etc.) falls on August 14. To help ease the hardship of this later than usual payroll, Dr. Fletcher asked for an item to be placed for action later in the agenda to move the August 14 payroll up one week to August 7. He noted, however, that the second payroll will not be until three weeks later to get the payrolls back on the 15-16 schedule.

In later discussion of this situation, Chairman Preston asked that representatives of teachers, staff, and central office personnel meet for discussions on the payroll calendar issue and come up with a plan to present to the board in the fall to eliminate this happening again in the future.

# 104.A.8. SIG Update (added to agenda)

Dr. Fletcher stated that though it looks promising that the high school will come out of PLA status once all scores are released in the fall, the high school is still allowed to apply for funds to help sustain students' increased achievement. An official due date for the grant application has not been released, but they have been guaranteed the opportunity to apply for the additional funding because it is being divided among the current PLA schools. Dr. Fletcher shared the steps taken to seek input on the School Improvement Grant (SIG) strategies from all stakeholders, including meetings with high school staff, email communications and public meetings.

"To make you (board), the high school and the community aware of these efforts: I met with the high school faculty first then the high school's Advisory Council to talk about priority needs. I also met with Rotary to seek input and inform the community about the SIG opportunity. Ms. Webb, Ms. Humphrey and Ms. Colvin met with the CDIP committee to get their ideas on what we need to do to move to the next level of academic achievement. In addition, several sections of the grant have been divided among central office staff and the high school to take the lead in writing the grant."

One of the things the high school staff identified as a needed strategy is a Freshman Academy that would necessitate another position be added in order to schedule and operate it successfully. High school staff also requested content-specific professional development, and they are in the process of identifying specific professional development opportunities. Once the due date for the grant is released, there will be 6-10 days to complete and submit the grant application.
