1. Your young adult's academic **Progress Report** is enclosed. Please note that there are approximately seven weeks left of this school year. If you have any questions regarding your student's progress in a course, please contact the teacher of the particular course via email or phone.

3. **NWEA Assessments** will take place on **Tuesday, April 13**, beginning at 7:45 a.m. for **all Cohort A and four-days per week in-person** students in grades 9-11 (Cohort B will take these on Thursday, April 14). All grade 11 students will also take the **MEA State Science Assessment** (date tbd). Please view the enclosed letter to learn more about these assessments.
4. **Please continue to help us with the following to better engage your young adult in their academics:**
  - Students **may not choose** to attend remotely when they are scheduled to attend MA in-person.
    - **Only parents/guardians may communicate that their student must attend remotely due to illness (not the student).** If students have symptoms on the Covid-19 screener, they can attend remotely; however, that is the **only** reason.
    - Students scheduled to attend in-person are expected to attend in-person. Students who do not attend in-person as scheduled will be marked as absent unexcused and will not be able to join the live Google Meet.
    - Students who are marked as unexcused cannot attend co-curricular activities and athletics. (as stated in the [MA Student-Parent Handbook](#)).
  - **Please remind your young adult that when they attend on their scheduled remote days they are expected to attend their classes on time and stay logged in for the entire class period (M, T, TH, F).** Failure to attend remote classes for the full period will be documented as an unexcused absence.
  - **Wednesday Schedule.** Students are required to attend academic assistance sessions as requested by their teacher (s). Parents/guardians receive this schedule via email each Tuesday evening. Failure to attend will result in an unexcused absence. All students are expected to attend the 9 a.m. check in (if they are not requested for academic assistance).
