Permits and Fees:

Parking permits will be sold at registration for \$10.00. At the time of registration, the student will be required to show a valid driver's license, car registration, proof of insurance and a signed drug testing consent form. No permit will be issued without these documents.

After registration, permits may be purchased in the CHS Main Office for a \$10.00 fee. Permit prices will be prorated by semester. If a permit is revoked due to disciplinary reasons or violation of parking regulations, no refund will be given.

Replacement Permits:

Permits are issued to a student and may not be transferred from one person to another. If a student drives a vehicle other than the one that was identified at the time of registration, the student must transfer the permit from one vehicle to the other. In the event that a permit becomes lost or stolen, a replacement permit may be purchased in the Main Office for the full price of \$10.00. Any duplication or transfer of a permit will result in disciplinary action.

TO ACQUIRE A PARKING PERMIT AT REGISTRATION, STUDENTS MUST BRING:

- 1. A VALID DRIVER'S LICENSE
- 2. A VALID REGISTRATION FOR THE CAR TO BE DRIVEN BY THE STUDENT.
- 3. PROOF OF INSURANCE
- 4. \$10.00 REGISTRATION FEE
- 5. SIGNED DRUG TESTING CONSENT FORM
- 6. A COMPLETED PARKING PERMIT REGISTRATION FORM

CHS PARKING

Authority and Purpose:

The following rules and regulations have been adopted for control of vehicles on the campus of Centralia High School (CHS) in order to promote the safety and convenience of students, staff and visitors.

In order to protect property, prevent trespassing, and maintain peace and order, CHS staff members are authorized to enforce regulations controlling vehicles on CHS property. Failure to adhere to these regulations will result in revocation of parking permit, towing (at owner's expense), or other disciplinary consequences. If permit is revoked for any reason, no refund of the parking fee will be given.

All students who operate or expect to operate a motor vehicle on the CHS campus, either regularly or occasionally, must register with school officials and secure and display a valid parking permit while the vehicle is on the CHS campus. Registration must occur before a vehicle is parked or operated on the CHS campus.

Parking Rules & Regulations:

Students must comply with the ILLINOIS MOTOR VEHI-CLE CODE. In addition, the following regulations shall apply 24 hours a day, 7 days a week, to all operators of motor vehicles as soon as the vehicle enters onto school property.

- The Centralia High School District #200 reserves the right to the reasonable search of any vehicle entering or parked on school property.
- 2. Permits **MUST** be hung from the rearview mirror with the permit number facing the front window.
- 3. Students must park in the STUDENT PARKING AREA ONLY from 6:00 a.m. until 3:30 p.m. on days school is in session. Student parking spaces are designated by two white lines or one white and one yellow line.
- Only pull-in parking will be allowed. All vehicles shall park within the parking lines of the lot. Driving or parking on unpaved areas is prohibited.
- Once a vehicle enters school property, it must be parked immediately. All persons in the vehicle must vacate the vehicle and clear the parking lot. Loitering before school or during school hours is not acceptable. Failure to comply with this rule will result in disciplinary action.
- Students may not go to their cars during the school day for any reason unless cleared by the Attendance Office.
- No illegal material (e.g. drugs, alcohol, weapons, explosives, or stolen property) may be transported, secreted, or kept in any motor vehicle brought on to school property.
- Discarding of any waste materials from any motor vehicle is prohibited.
- Any student who tampers with any vehicle in the parking lot will be subject to disciplinary and/or police action.



Rules and Regulations cont.

- 10. The speed limit on the CHS campus is 10 mph.
- 11. Reckless driving (as determined by staff) is prohibited. Any person who drives any vehicle with a willful or wanton disregard for the safety of persons or property is guilty of reckless driving. Operators of motor vehicles shall not transport students or other persons in the beds of pickups or on the fenders of vehicles, etc.
- 12. No person shall operate any motor vehicle in such a manner as to cause or allow to be emitted squealing, screeching, or other such noise from the vehicle's tires. Unusually loud exhaust noise or sound from audio equipment is prohibited.
- 13. Drivers of motor vehicles must come to a complete stop at all stop signs, yield the right-of-way to school buses, and observe all signs posted or painted on the premises.
- Students observed circumventing the speed bumps or barriers will lose their parking privileges.
- Parking privileges may be revoked based on excessive absences or excessive disciplinary problems.
- 16. The school assumes no responsibility for loss of personal property or damage to cars parked on school property.
