PUBLIC DISCUSSION

WCLEA – Mrs. Sharon Baumgard-Teachers are glad to be back and in a routine after time off from the snow days. The Elementary held "Right to Read" week with books from Dr. Seuss. The Elementary will be having a "March Madness" contest with students reading books.

Christy McCutcheon read a letter to the Board from a group of staff members that have concerns over the direction of the current leadership. They feel their elementary team is broken and there is division. There are some staff worried where the direction may be headed under the current leadership. There is too much micro management and not enough allowing staff to do what they do best. Over the years, with the current leadership, the Elementary team has lost over 20 staff members.

Tiffany Tornes expressed her concern over the "pop up" virtual learning. She asked if there was another reason, besides girls basketball tournament, why we were put on virtual learning Thursday (03/11). Mr. Baldwin answered that there was no other reason. The sport teams have such a strong community support that it would be difficult to have a normal day of school. Mrs. Tornes asked if there were other options besides having a virtual day on Thursday and Mr. Baldwin responded that there was but thought this was the best fit. Mrs. Tornes asked about the 70% success rate of the virtual day in December, stating that this was scheduled because it was well planned in advance. What about the unplanned day we had in February (snow day) and this Thursday, how successful will that be? Mr. Baldwin agreed with Mrs. Tornes and stated he himself did not like the virtual days but it would be better than adding the days on at the end of the year where students are doing nothing.
