The Board of School Trustees (Board) of the Logansport Community School Corporation (Corporation), Cass County, Indiana, met in regular session at LCSC Administration Building, 2829 George Street, Logansport, IN 46947, at 5:00 P.M. on Monday, March 8, 2021.

Upon a motion by Mr. McCord and a second by Mr. Meagher, the recommendation to approve ERATE Category 2 switching and access point hardware purchase was unanimously approved. The cost of this 2nd phase will be \$176,842.70 and LCSC's portion will be 20% or \$35,3968.54 of the total project.

Upon a motion by Mr. Hess and a second by Mr. Meagher, the consideration to adopt Resolution Opposing the Establishment of Education Scholarship Account and the Expansion of the Indiana School Choice Scholarship program was unanimously approved. Therefore, the school board of Logansport Community School Corporation opposes and condemns the establishment of education scholarship accounts and the expansion of the Indiana choice scholarship program as proposed by members of Indiana's General Assembly in House Bill 1005 and other bills that directs funding away from Indiana Public Schools.

Upon a motion by Mr. McClure and a second by Mr. Meagher, the consideration to approve the establishment of the Roberta 'Bert' Chambers Memorial Scholarship for a graduating LHS senior was unanimously approved.

Mr. Dibble gave a technology update.

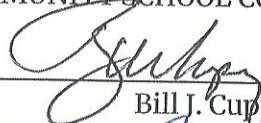
Mrs. Hagerty gave a curriculum update.

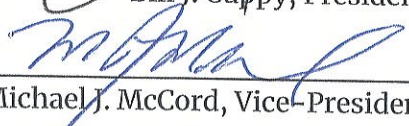

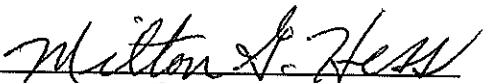

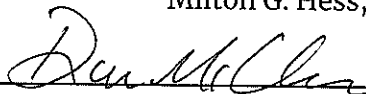
There being no further business to come before the Board, the meeting was adjourned at 6:14.
