



Mid-Del Schools Legislative Goals

<u>2017-2018</u>

- 1. Mid-Del Schools supports the development of a long-term funding plan that will raise the revenue necessary for all Oklahoma students to achieve state educational standards. This includes increasing compensation for certified and support staff, and operational revenue for school districts.
- 2. Mid-Del Schools supports the states full funding of health insurance for certified and support staff.
- 3. Mid-Del Schools supports legislation to protect and preserve the Oklahoma Teachers Retirement System as a defined benefit plan.
- 4. Mid-Del Schools supports the development of a separate state funding formula for virtual schools.
- 5. Mid-Del Schools supports accountability measures that are research-based with multi-criteria indicators of student growth. We believe that the same accountability measures should apply to all schools that receive public funding including schools that benefit from tax credits.
- 6. Mid-Del Schools supports legislation that will give school districts an equal voice with city and county government in the development and approval of Tax Increment Financing Districts financed by ad valorem revenue.
- 7. Mid-Del Schools supports legislation that eliminates the U.S. History test from the state testing program.
- 8. Mid-Del Schools supports legislation that reduces state intrusion in local school board matters; we support the expansion of charter schools only with the approval of the local board of education.
- 9. Mid-Del Schools supports a state question to remove the super majority requirement for school districts to pass bond issues.
- 10. Mid-Del Schools supports a state question to repeal or modify State Question 640.
- 11. Mid-Del Schools will strongly oppose any legislation in support of school vouchers.
