- **Enrollment Update:** Enrollment is steady. Preschool enrollment will open March 22nd. We have started to receive calls from parents interested in transferring their kids here next year. Mr. Smith will attend a meeting on Thursday to discuss Inter-District Transfers.
- **CTE Construction Update:** Mr. Smith met with Cleary Building Solutions, the contractors that will construct the building across the street. They anticipate they will have the shell of the structure built by May 10th, followed by plumbing the next week and concrete the week after that.
- **COVID Update:** The CDC is considering changing COVID guidance in schools by reducing required distancing from six feet to three. This change would allow for all of our students to return full time instruction. Mr. Smith also announced that fans will be allowed to watch football games as long as social distancing and mask requirements are being followed. Nothing has changed as of today for indoor sports. He is hoping for an update tomorrow that may allow for some fans for volleyball.
- **Board Member Reelection:** Mr. Smith reminded the board that the deadline to submit for reelection is March 18th.
- **PERS Pension Bond:** Denyce Kelly presented to the board some options for the board to consider in regards to the PERS Pension Bond. In order to offset the increase in PERS, the district could sell the bond and reinvest. Other districts are exploring selling too. Denyce and Raymon will continue to gather information and bring a recommendation to the board at the April meeting.
