The Litchfield Board of Education held their regular monthly meeting beginning at 6:00 p.m. at G.A. Sihler School ,601 South State Street, Litchfield, IL. 62056. Board members in attendance included: Julie Abel, President; Ron Anglin, Vice President; Valerie Cain, Secretary, David Belusko; Mark Bloome, Mike Fleming and Gregg Hires. Also in attendance were: Dr. Gregg Fuerstenau, Superintendent. Kris Adamson, Recording Secretary. Administrators: Jennifer Thompson; Russ Tepen; Jeremy Heigert and Adam Favre. John Hanafin of News Herald and Mary Herschelman, Journal News.; Mark Elvers, LEA representative. Concerned parents and citizens. Masks were worn and social distancing was adhered to the guidelines.

# Fogleman Quarterly Update

Mr. Roger Krabbe and Mr. Chad Ruppert of the Bank and Trust addressed the Board of Education in regards to the Fogleman Scholarship Trust during the Citizens Agenda portion of the meeting. Mr. Ruppert, farm manager for the trust, announced that it had been a good yield year for the crops overall. The tiling project from last year helped. Renters signed leases in December. Rent would remain the same but would look at increases next year if necessary. Mr. Krabbe gave his report on the investment side of the trust. The Fogleman Trust is estimated to be worth \$8.2 million dollars. With the one-third method of calculating scholarship funds, it was recommended to the Board by Julie Abel and Roger Krabbe to set this year's scholarship amount to \$2300.00. This amount would then save their reserves for the future. At this time, it is estimated that 24 new scholarships and 62 renewals could be given out this year.

The Students will have met the state and district requirements to earn a high school diploma in December of 2021 They are requesting to graduate at that time. Mr. Hoster and Mrs. Cress have reviewed their educational status and have forwarded their requests to the Board. Packet includes letter of request as well as support letters from parent/guardians. Bills payable in March 2021 total \$250,347. From Education fund \$163,967; from O&M \$43,738; from Transportation \$29,314; from Capital Projects \$11,411; from Tort \$1,916. Ending balance in all funds at February 28, 2021 is \$30,292,607. Balance in operating funds is \$7,919,761; balance in Capital Projects is \$13,407,675; balance in Health-Life-Safety is \$7,664,158.

# <u>Information</u>

Enrollment for February was 1309. Kelley Walker, director of the MAKE IT program, submitted her monthly report. Bob Witter, Buildings and Grounds/Transportation Director, submitted his monthly report for the board packet. The evenings presentation was on the status of the District's Career and Technical education program. Dr. David Lett, Career

and technical education coordinator for the district gave a brief overview of where his team started and their goals for the following school year. Starting with kindergarteners and moving up to seniors at the high school, this program is clearing the path for students to decide on their futures. Abby Carlson, Career Services coordinator, spoke on the iDream/ICreate program. The district is working with Val Belusko of the University of Illinois Extension office. The Galaxy program is a careers unit offered to kindergarten through fifth grade. Mr. Ellis Henley currently teaches an eight grade class on careers. One of the main lessons taught is developing soft skills needed for jobs. Next Fall, junior will be offered a new class on consumer education and careers. Dr. Lett stated that the Innovation center is on hold, but is on the governor's radar for funding. CTE programs in the county are strengthening and expanding even prior to the center opening its doors. There are many hurdles still to breach. With each accomplishment a pathway is opening for a student in the Litchfield School District. The Board was interested in ideas of community involvement through mentoring programs, internships, and summer work programs. Administrators gave an update on summer camp programs. The elementary staff is participating in a book study on literacy. They extended the invitation to Board members. Mr. Favre and Mr. Heigert will present the literacy program at the April meeting. Mrs. Thompson stated that MAP testing will continue to April and May. She will present a new Math curriculum at the April meeting for board approval. Dr. Tepen explained that with the threat of mandatory summer school looming over underachieving students' heads, there has been an influx of student work and participation. Dr. Fuerstenau complimented the Athletic Directors and the videotaping crew for their work and time into getting activities live streamed for fans to watch. He thanked Mrs. Jo Brummet and the student council for a successful homecoming week during a pandemic. The administration is working with the city on the State Street building project.
