Describe method(s) for identifying barriers

Westview staff are required to make contact with all parents in their classroom with in one week of school starting. This could be in person, over the phone, by email, or by electronic video. We feel it is important to make that connection and maintain it all year long. If there is something that is a barrier then it can be identified in this first contact. We have also upgraded our website and student messaging system so that parents can select the language in which they wish to be notified. Surveys and questionnaires are also sent throughout the year via various methods.

The needs of parents and family members to assist with the learning of their children, including engaging with school personnel and teachers

Describe method(s) for identifying needs

Again, the staff is required to make contact within the first week of school. Surveys and questionnaires are given throughout the school year to identify needs. Parents and students also have access to all grades, assignments, teacher/staff emails twenty-four hours of the day to ask any questions or by phone as each teacher has a google phone number that parents and students can call or text.

Strategies to support successful school and family interactions

Describe method(s) for identifying strategies

Westview plans to have many family engagement nights throughout the school year in person but we have also learned how to be creative and involve parents and families through social media, zoom, and other various means this year. Each teacher is required to create a google classroom avitar that families and students were trained on that explains every aspect of the classroom and gave families a central location to look for important announcements or events. There are also various ways that parents and staff are in communication with each other. Parents have access to all student grades and assignments electronically at any time needed. Parents also receive emails from teachers if there are any areas that need to be addressed.
